

Woking parking review 2022: Decision report

A document explaining our final decisions on proposed parking schemes following public advertisement and feedback

Introduction

This document sets out our final decisions about which schemes should go ahead, with or without changes, as part of our Woking parking review 2022.

Our parking proposals were 'advertised' by way of a press notice published in the Surrey Advertiser on Friday 24 June 2022, and there then followed a four week 'objection period' which ended on 22 July 2022, to allow for the public to make representations regarding the proposals. To raise awareness of the proposals, in addition to the press notice we also put up 173 site notices where the new restrictions were proposed, and notified people most directly affected by post. This included three different letters to around 165 residents with proposed new permit schemes, and about 255 notification cards to anyone else at addresses at or close to the remaining proposal locations. Copies of the proposal documents were made available to view in person at Woking Library, West Byfleet Library, Knaphill Library and Merrow Depot, Guildford. Copies of the proposed documents were made available on our website, where there were also online forms for people to use to let us have their views.

We received a total of 187 responses to the proposals via our online form, letters, and emails, on 36 of the new parking scheme proposals.

This report lists all the proposals and presents a summary of the type and number of comments received, our responses where appropriate, and the final decisions and reasons for them for each one. It does not contain a transcript of each objection made, but, as required by the regulations, each comment and objection was read and considered before any final decisions were made.

Only themes considered relevant to the proposals have been mentioned in this summary report. People often raise highway issues that are not part of these proposals, such as:

- Speed limits and enforcement, traffic calming, road safety, road layouts and geometry.
- Creation of additional parking spaces in place of grassed areas or verges.
- Resurfacing, potholes, and highway maintenance.
- Further new or modified parking controls.
- Off street car parks.
- Planning issues.

These are beyond the scope of the parking review and therefore such queries have not been addressed in this analysis. For further information and guidance, please see the [Annex 1 – Explanation of restriction types](#) at the bottom of this document.

Having advertised our intention to introduce the parking proposals, the regulations allow us to make minor modifications to them before their introduction without the need for further advertisement. Of course, we can also cancel a proposal entirely.

At locations where no objections or comments were received there is no analysis and the proposals will - unless otherwise stated - be introduced 'as advertised' i.e. without any changes from the advertised proposal. Where changes have been made, there will usually be a revised drawing in addition to the written description.

These decisions are now final and there is no appeal stage, although customers can ask us to reconsider any parking controls, whether old or new, at any time as part of the next parking review in the area.

If you are unsure of the meaning or effect of a parking restriction or control that we've proposed, please refer to [Annex 1 – Explanation of restriction types](#), found towards the back of this document.

Analysis

Both the commenter and objector are concerned about where the displaced vehicles are going to relocate to. Just to be clear the advertised operational hours of the single yellow line are 8- 9.30am and 2.30- 3.30pm Monday to Friday. Displacement will only be a maximum of three vehicles, and the dropping off and picking up of passengers will still be permitted during these times. With the restriction in place, this short length of Meadway Drive could work as a drop off/ pick up space with a constant turn over of vehicles. On-street parking will still be permitted in this space at all other times.

Analysis

The objector states that double yellow lines are unnecessary. There are no access issues for vehicles on a regular basis, and parking restrictions will remove valuable on-street parking, putting more pressure on what space remains. This could force residents to park in more unsuitable locations. It is possible this request was raised when some properties were having building works carried out, and there was an unusually high number of builders vans and materials in the street.

The objector admits that parking in the area is poor and asks for the grass verges to be taken up and replaced with parking bays instead in this location. The council doesn't undertake this type of work. It does not comply with the Local Transport Plan or the council's Greener Futures policies.

There are two expressions of support and installing parking controls on this junction will improve access, sightlines, and road safety.

Analysis

It is recommended to proceed with an amendment. Revoke the 20 minute limited waiting parking bay in the north east corner of Wilfred Street and convert it into a parking bay under Area 5 operational times and conditions instead. This bay was intended for use by shoppers to the grocery store that is no longer open.

There is insufficient support to move these three streets from Area 5 into Area 3 or make changes the existing restrictions on the three parking bays along Bridge Barn Lane. It is therefore recommended that these three streets remain in Area 5.

No changes were advertised to the length of the parking bay outside No's 2-4 Mabel Street as we did not know this was an issue. It can be assessed in the next Woking parking review.

We understand the conversion of four parking spaces during the day may cause concern for objector and other residents in the area. This work will not remove parking spaces. They will be enabled for electric vehicle owners to charge their vehicles between 8.30am and 6pm Monday to Saturday. The spaces would then revert back to all vehicle parking outside of the permitted electric vehicle only time period. Ownership of Electric and Hybrid vehicles may be low in the area, but it will increase as internal combustion engine vehicles decrease in number.

Analysis

Several valid objections have been received. Access to the end of Woodside Close could be an issue if these formal parking bays were introduced. Competition for on-street parking space within the area is high. In the short term internal combustion engine vehicles could be forced to park in the EVCP bays through lack of alternative space. Unintentional contraventions could result and Electric Vehicles would be unable to park and charge as intended defeating the objective of this project in the location at the current time.

On-street parking is not being completely taken away as the objector fears. The objective of these restrictions is to move the parked vehicles on Clifton Way further back from the junction of Ashton Road as will improve sightlines and road safety when exiting Ashton Road.

Analysis

The existing H-Bars in front of drives outside No's 2-3 and 3-4 are marginally short of the end of the raker curbs. In between these driveways there are still lengths of 3 and 4 full height curbs respectively where vehicles are likely to continue parking. Double yellow lines should be installed to improve and maintain access at all times.

No loading restrictions were included in this proposal. Therefore, any vehicle will still be able to stop on the yellow lines for up to 20 minutes to load/ unload passengers and goods. Vehicles displaying a valid Blue Badge can also park on the double yellow lines for up to 3 hours with their time clock displayed.

Analysis

It was difficult to show the change being proposed on the drawing clearly, as it was a lot of information to display in a small space. The written description in the Joint Committee report from April 2022 explained the proposal more clearly. This is the changes we shall be implementing. It stated:

Introduce double yellow lines on the eastern side of Royston Avenue up to the entrance of Laurel Grange to prevent vehicles parking on and obstructing the footway.

On the eastern side of Royston Avenue revoke the existing 9am – 5pm Monday - Friday restriction alongside the library. In its place introduce 5 metres of double yellow line at the southern end of Royston Avenue. Also introduce 5 metres of double yellow line south from the library car park, leaving an unrestricted gap in between. A small amount of parking is possible here allowing for some additional safety and sightline assistance.

A lot of the responders interpreted the drawing as proposing to have double yellow lines on both sides of Royston Avenue at the southern end. This is not the case.

Alongside Laurel Grange there will be double yellow lines. This will keep the footway clear at all times improving pedestrian access along the avenue. On the library side of Royston Avenue there will be a short extension to the double yellow lines at the southern end and a 5-metre length introduced south of the library car park to maintain access. The space in between will be unrestricted where parking will be allowed at all times.

The restriction will not be upgraded to a double yellow line, but it will be signed once again. The restriction time on the Traffic Regulation Order is Monday – Saturday 8.30am -6pm. The single yellow line has been missing it's sign for a long time. Parking will once again be prevented on these days between these hours. The additional length of single yellow lines on the ground in Stream Close will be added to the Traffic Regulation Order

Analysis

We understand the conversion of four parking spaces may cause concern for residents, but the intention is not to remove the parking spaces. They will be enabled for electric vehicle owners to charge their vehicles between 8.30am and 6pm Monday to Saturday. The spaces would then revert back to all vehicle parking outside of the permitted electric vehicle only time period. The alternative suggested larger village hall car park is private land and cannot be considered by the County Council as part of this project.

Analysis

There is high demand for the on-street parking space in this residential road, but access needs to be maintained to the far end of the street for rubbish collection and emergency service vehicles. The double yellow lines to be introduced are the minimum required at the narrowest section of the street to achieve this, without losing much on-street parking space. Three consultations with the residents over past years have not shown enough support for joining the West Byfleet Controlled Parking Zone.

They will be enabled for electric vehicle owners to charge their vehicles during the hours and days stated only. The spaces would then revert back to all vehicle parking outside of the permitted electric vehicle only time period. The local properties have their own off-street parking, and the proposed location is used as over-flow parking by residents with restricted parking. Recommendation to review the use of garages are welcome as suggested by the commentor, however these properties are under free hold ownership.

Analysis

Some of the businesses would benefit from a regular turn-over of vehicles with parking spaces becoming available often, such as the grocery store (Co-op), butchers, chemist's, and coffee shop. A quick turn over of visitor parking would not benefit others, such as the hairdressers or residents who live above the shops. It is therefore recommended to proceed as advertised and mark out the western side of Marshall Parade, (the Co-Op side), with timed 2 hour parking bays operational Monday to Saturday 8.30am to 6pm. The parking bay on the eastern side (Coldharbour Road) is to remain unrestricted. This will allow for customers and residents to gradually get used to the new parking arrangements. By the time of the next parking review the issue for residents who live in the flats above the shops, should be clearer, their private parking facilities and their leases will have been sorted out.

If vehicles do displace to the opposite side of the road, then we'll have to assess the impact of that in the next parking review.
