**The Surrey County Council**  
**Various Roads in the District of Mole Valley**  
**Temporary Prohibition of Traffic Order (No.1) 2023**

On 01 March 2023 Surrey County Council made the above mentioned Temporary Order under Section 14(1) of the Road Traffic Regulation Act 1984 the effect of which will be to prohibit vehicles from entering or proceeding in: - **a)** That length of D289 Abinger Road, Coldharbour and Leith Hill that extends from its junction with C43 Leith Hill Road, to its southern junction with D296 Broomehall Road. Vehicular traffic will be diverted via D296 Broomehall Road, A29 Stane Street, B2126 Forest Green Road, B2126 Ockley Road, B2126 Etherley Hill and C43 Leith Hill Lane. **b)** The entire length of D297 Anstie Lane, Coldharbour. Vehicular traffic will be diverted via D297 Henhurst Cross Lane, A29 Beare Green Road, A29 Stane Street, D296 Broomehall Road and D289 Abinger Road. **c)** The entire length of D296 Broomehall Road, Coldharbour and Leith Hill. Vehicular traffic will be diverted via D289 Abinger Road, D297 Anstie Lane, D297 Henhurst Cross Lane, A29 Bear Green Road and A29 Stane Street. **d)** The entire length of D289 Coldharbour Lane, Dorking and Coldharbour. Vehicular traffic will be diverted via D2822 Falkland Road, D2805 Barrington Road, A2003 Horsham Road, A2003 Flint Hill, A24 Horsham Road, A24 Beare Green Roundabout, A29 Ockley Road, D297 Henhurst Cross Lane and D297 Anstie Lane. **e)** The entire length of D283 Friday Street and D283 Noons Corner Road, Leith Hill. Vehicular traffic will be diverted via D282 Hollow Lane, A25 Guildford Road and D285 Sheephouse Lane. **f)** The entire length of D297 Henhurst Cross Lane, Coldharbour and Leith Hill. Vehicular traffic will be diverted via A29 Beare Green Road, A29 Stane Street, D296 Broomehall Road, D289 Abinger Road and D297 Anstie Lane. **g)** The entire length of D288 Logmore Lane, Westcott. Vehicular traffic will be diverted via D288 Westcott Heath, A25 Guildford Road, A25 Vincent Road, D2822 Falkland Road and D289 Coldharbour Lane. **h)** The entire length of D290 Mole Street, Ockley. Vehicular traffic will be diverted via B2126 Ockley Road, B2126 Forest Green Road, A29 Stane Street and D290 Cathill Lane. **i)** The entire length of D285 Sheephouse Lane and Damphurst Lane, Abinger. Vehicular traffic will be diverted via C43 Leith Hill Road, C43 Abinger Road, D282 Hollow Lane and A25 Guildford Road. **j)** The entire length of D292 Standon Lane and D290 Cathill Lane, Ockley. Vehicular traffic will be diverted via C49 Walliswood Green Road, C49 Horsham Road, B2126 Ockley Road, B2126 Forest Green Road and A29 Stane Street. **k)** The entire length of D289 Tanhurst Lane, Abinger. Vehicular traffic will be diverted via C43 Leith Hill Lane, B2126 Etherley Hill, B2126 Ockley Road and B2126 Holmbury Lane. **l)** The entire length of D293 Weare Street, Ockley. Vehicular traffic will be diverted via A29 Stane Street and B2126 Cole Street. **m)** That length of D298 Wigmore Lane, Beare Green that extends from the northern side of its junction with A24 Capel By-Pass, to the southern side of its junction with A29 Ockley Road. Vehicular traffic will be diverted via A29 Ockley Road, A24 Beare Green Roundabout and A24 Capel By-Pass.

This Temporary Traffic Order is required to enable Surrey County Council to carry out the removal and installation of signposts and/or vegetation clearance and/or highway maintenance and/or resurfacing works. These works are anticipated to be carried out between the hours of 9am and 5pm, as soon as possible within the 18 month period of operation of this Temporary Traffic Order which commences on 03 March 2023. Advanced warning signs will be displayed and the temporary closures which are each anticipated to be required for 3-5 days, will only operate when the relevant traffic signs are displayed. Access will be maintained for pedestrians and, dismounted cyclists and equestrians at all times. Access for emergency vehicles, residents and businesses will be maintained via the diversion routes described. In the event that it is necessary to restrict any access at any time under Section 3 of the Act, the road can only be closed for a maximum of 8 hours in any 24-hour period. Any vehicle found to be obstructing the highway during these works will be removed to a suitable location outside the limits of the works after all reasonable methods have been undertaken to identify and contact the vehicle's owner.
