## A31 Shepherd and Flock Roundabout and A31 Farnham By-Pass, Farnham Temporary Traffic Management Order 2023

On 08 February 2023 Surrey County Council made the above mentioned Temporary Order under Section 14(1) and (7) of the Road Traffic Regulation Act 1984, the effect of which will be to:

## (1) Prohibit vehicles from

- (a) driving or proceeding in the length of road specified and described in Schedule 1 to this Notice at a speed greater than 30 MPH.
- (b) driving or proceeding in the length of road specified and described in Schedule 2 to this Notice at a speed greater than 40 MPH.
- (c) entering or proceeding in the length of road specified and described in Schedule 3 to this Notice.
- (2) Suspend "The Surrey County Council (Various Roads in the Town of Farnham in the Borough of Waverley) (50 mph Speed Limits and Amendment) Order 2013" and "The Surrey County Council Farnham By-Pass (A31) Farnham (50 mph Speed Limit) Order 2009" and any Speed Limit Order made or having effect as if made under Sections 82, 83 and/or 84 of the Act insofar as affect the lengths of road specified and described in Schedule 1 and Schedule 2 to this Notice.

This Temporary Traffic Order is required to enable Surrey County Council to carry out resurfacing and/or improvement and/or maintenance works. These works are anticipated to be carried out between the hours of 7pm and 5am, within 7 days of the 18 month period of operation of this Temporary Traffic Order which commences on 13 February 2023. Advanced warning signs will be displayed and the temporary closures and speed limits will only operate when the relevant traffic signs are displayed.

No sole access to property will be affected. Access for emergency services, pedestrians and, dismounted cyclists and equestrians will be maintained via at all times. Access for residents and businesses will be maintained via the vehicular diversion route: - South Street, East Street and Guildford Road.

The temporary speed limit imposed by this Order shall not apply to vehicles used by special forces in accordance with the Road Traffic Exemptions (Special Forces) (Variation

and Amendment) Regulations 2011 or in respect of anything done with the permission or

at the direction of a police constable in uniform or in accordance with any restriction or

requirement indicated by traffic signs placed on the highway by or on behalf of the Police.

Schedule 1

That length of the A31 Farnham By-Pass, Farnham that extends from the eastern side of

the access road to "Hatch Mill", to its junction with A31 Shepherd and Flock Roundabout.

Schedule 2

That length of A31 Shepherd and Flock Roundabout, Farnham that extends from its

junction with A31 Farnham By-Pass, to the southern side of its junction with B3228

Guildford Road.

Schedule 3

That length of the eastbound carriageway to A31 Farnham By-Pass, Farnham that extends

from the eastern side of the access road to "Hatch Mill", to its junction with A31 Shepherd

and Flock Roundabout.
