Support for Surrey County Council's Updated Bus Service Improvement Plan (BSIP)

Safeguard Coaches is pleased to support the Enhanced Partnership (EP) established between Surrey County Council and Surrey's local bus service operators and the Bus Service Improvement Plan (BSIP) that has emerged from the EP.

Partnership working is the right way to deliver the best local bus services in Surrey as it draws together the complimentary skills and responsibilities of key partners.

We support the resulting BSIP, particularly measures designed to increase average bus speeds and reduce inconsistent performance of the road network on which local bus services depend. We strongly support initiatives designed to allocate more road space and give greater priority to sustainable bus transport as such measures make bus services more attractive, which generates more use, and more efficient (fewer resources required to deliver a given level of service), hence less expensive to operate, allowing bus fares to be as competitive as possible. Greater use of local buses is good for Surrey's environment, potentially reduces car traffic (and attendant congestion, air quality, noise and segregation issues particularly in our struggling town centres) and increases mobility for those without access to cars which helps provide better equality of opportunity, for example, to the employment market and essential services (eg GP surgeries).

Since the conclusion of a damaging period of competition ('bus war') and the ravages of the Covid Pandemic we have seen patronage of the local bus routes we provide (mostly commercially) recover to pre-pandemic levels and, on the back of that, recently invested in 5 brand new and one pre-owned buses – a total investment of almost £1M – to modernise as well as expand our bus fleet. Four buses from 2000, 2003 and 2008 were replaced. We are currently considering further investment in our local bus fleet for 2025.

We confirm that we will continue to work with Surrey County Council, other bus operators and stakeholders to deliver the key objectives of the updated BSIP.
