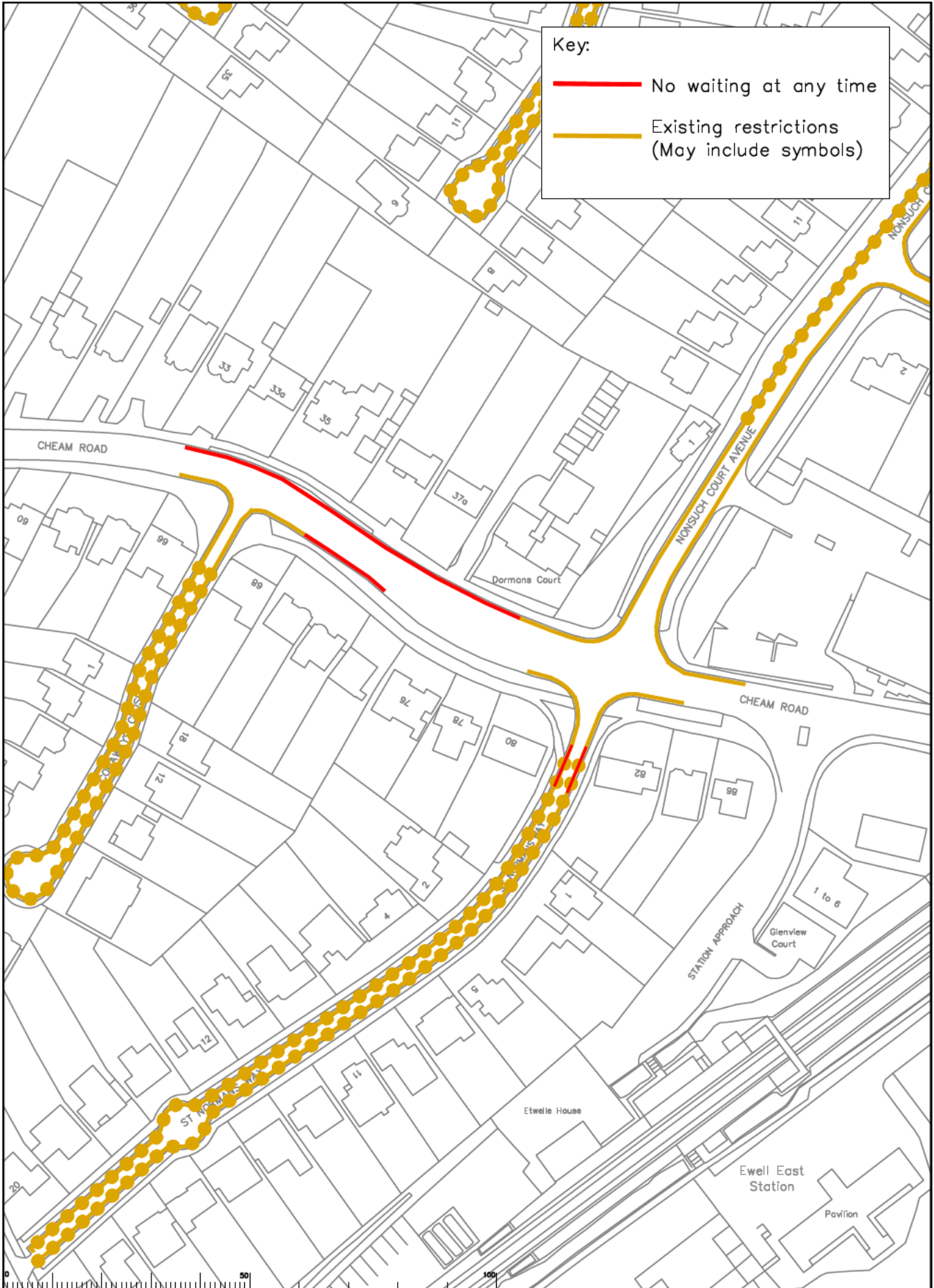
POSITION OF BUS STOP

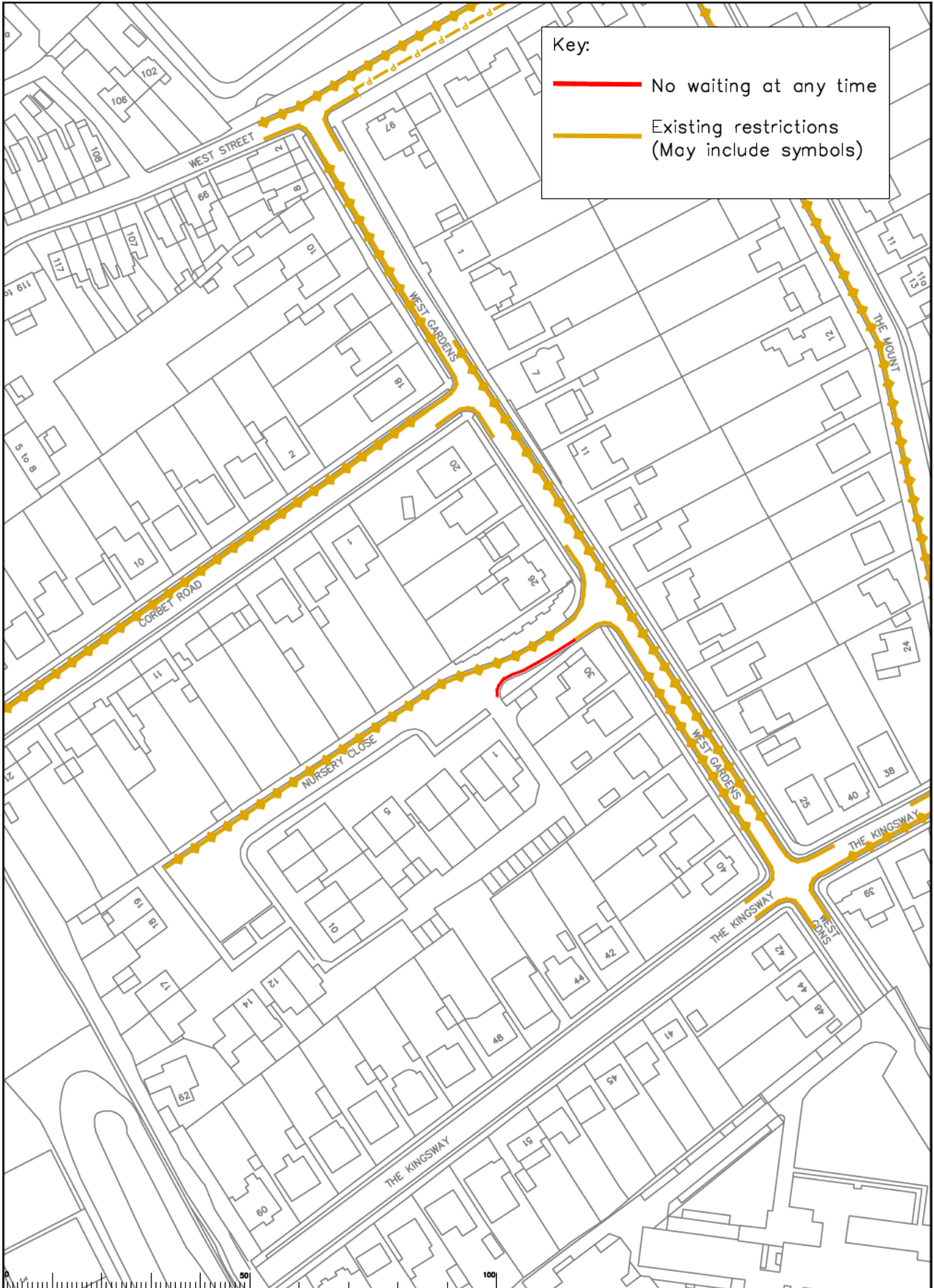

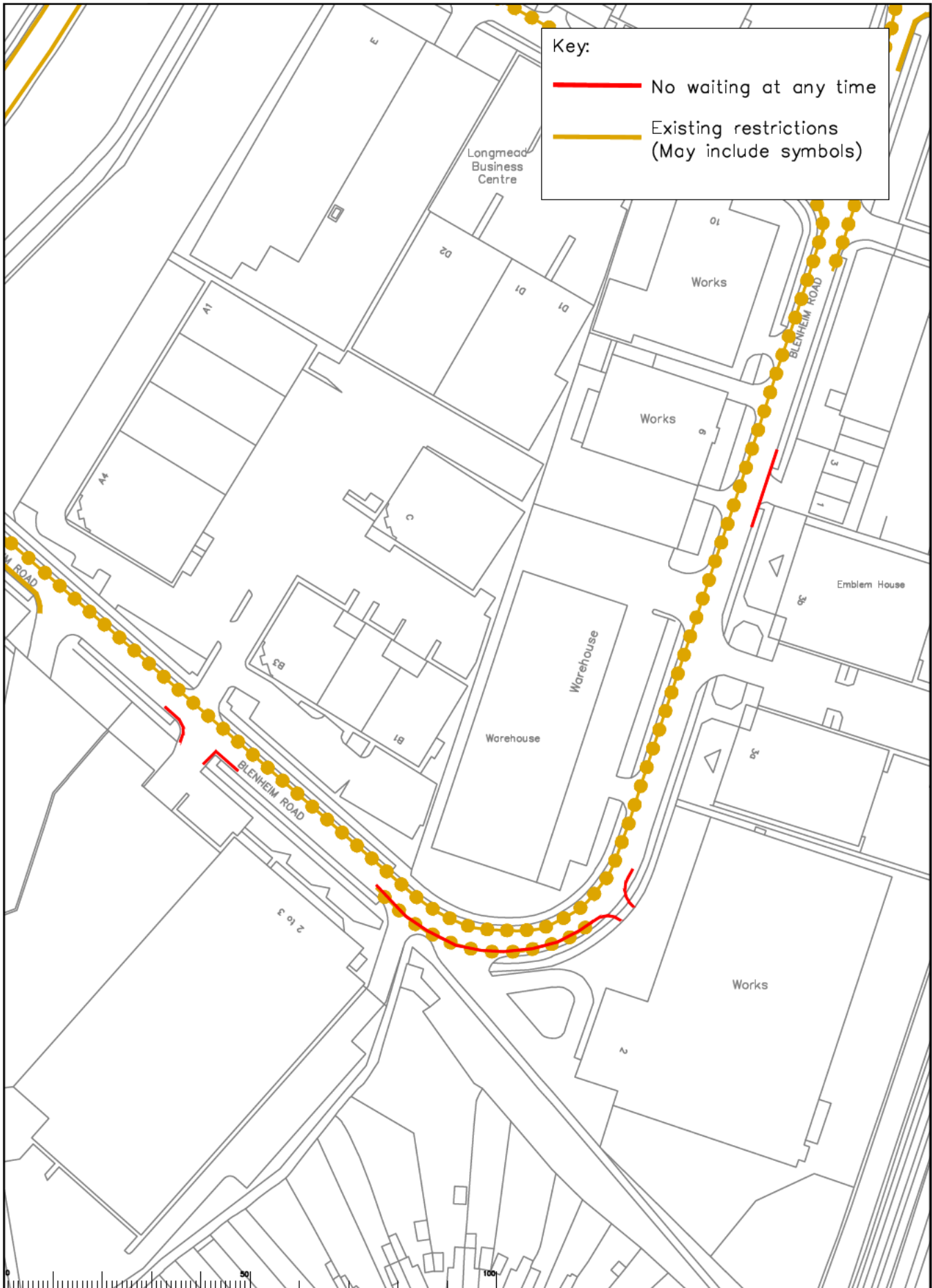

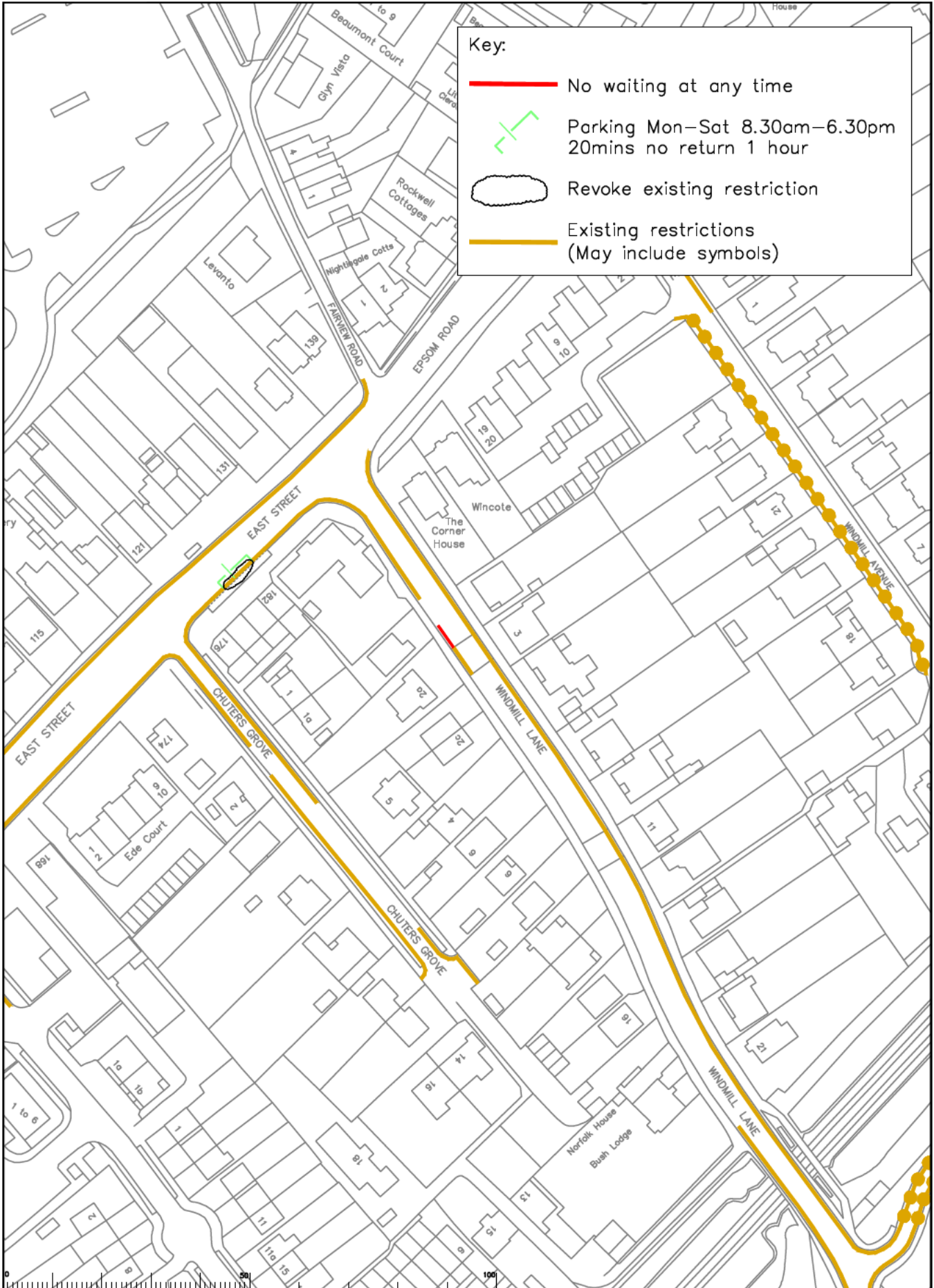
