South West Surrey Valuing People Group January 2023

Questions Answers and Comments on Direct Payments <u>for Chris Esson</u>



Pauline asked: if Surrey County Council knows it is hard to find and employ a personal assistant?

Chris replied that Surrey County Council are aware of this.

Pauline asked: How many people from the Personal Assistant recruitment campaign engaged and became personal assistants?







Chris replied: The campaign took place in Mid Surrey, in Dorking by the Surrey independent living council. Around 300 people engaged with the webpages, 60 of those 300 went on to book a place for the personal assistant training course. However, they aren't sure how many of the 60 became formal personal assistants.

Pauline asked, how much flexibility is there to for people to pay Personal Assistants themselves?

Chris replied – there is flexibility if people would like to contribute more, they can.











Pauline asked, does the budget allow for agency rates, which tend to be higher?

Chris replied: The direct payment budget can adapt to the agency rate. It is common for people to use care agencies to start with, until they find a personal assistant. So, there is flexibility.

Pauline asked what the hourly rate is now, and what it will go up to in April 2023?

Chris replied: the current hourly rate is £11.05 this will go up to £11.95 in April 2023.

Chris said that letters should be sent just before April notifying people of any increase in their budgets.







Pauline replied that the cost of services will increase too, especially given the cost-ofliving crisis, how will this impact people's budget?

Chris replied, if say for example, day care services' cost increased, go to social care. They will do a social care review and increase the budget to the correct level, to match the increase. This is mainly applicable to services that Surrey County Council are already aware of.

Pauline noted that there is no warning to service costs going up.





Department for Work & Pensions



Chris replied to sometimes Surrey County Council also have the same issue. It is best to challenge unreasonable rates with the provider.

Dan from Post 19 asked: if direct payments and benefit payments are the same? Chris replied with no benefits are paid by the Department of Work and Pensions (DWP). Direct Payments are paid through Adult Social care from the local authority.

Tony asked Chris- how do you see training going forward, to meet legislation?

Chris replied: How personal assistants are trained is to help them be better at their jobs. This is done through



Surrey Skills Academy. They offer formal, but not mandatory training, Surrey County Council are able to offer more training if Tony commented that on the 1st of May the Care Quality Commission (CQC) are enforcing quality checks how do we monitor that no one is left behind?

Chris replied: Direct payments, and agencies are subjected to inspection. However, personal assistants are not subjected to CQC inspection. This is unlikely to change going forward.







When people hire a personal assistant, they are effectively the employer, therefore, can judge the quality of performance. Therefore, they are responsible, this is a risk of hiring a personal assistant.

Julie asked what safeguards are in place? Such as a DBS check.

refer Surrey Independent living council (SILC) undertake DBS checks.

Julie commented: that there is a lack of formal/ regulated quality checks for personal assistants. What if someone lacks the capacity, and practitioners review a case once a year. How do we know if someone is being exploited?



Chris – where someone lacks capacity to have a direct payment, unless they have a power of attorney, who will act in the person's best interests we do not offer Direct Payments to them (not eligible).




