They provide information to organisations who provide care and support on who may require services now and in the future.



Short Breaks Cabinet Report.

Surrey County Council knows that carers are key in supporting the people they care for.



It is important they have regular breaks from their caring responsibilities, so they can continue to support the person to live at home.




Together with our partners we will develop a range of options that improve outcomes and support for individuals and their families when offering a short break.

Agreed to build two new 8 bedded Surrey County Council developments that offer bespoke, modern facilities one in the East and one in the West of the County. This ensured equity of access across the County.



Agreed a proposal to remodel short breaks offer to work with market to ensure we have a more diverse short breaks offer.





Emily Lodge.











Emily Lodge is a new 8 bedded Surrey County Council short breaks service in Woking.

A similar service is being built in Banstead.

Development of Supported Living Accommodation.

Since the programme began in 2019 Surrey have worked with our providers to develop new homes.

- 410 units have been delivered.
- 246 people with learning disabilities and /or autism have moved from residential care to supported living.
- Individuals are enabled to develop their skills and live in their local communities.



Horley (Kings Rd) - Ready September 2025

- 2 shared houses: 5 people can live in each one – all bedrooms are ensuite with large living areas.
- 6 flats: for single occupancy plus ground floor communal space.



West Byfleet (Magdalen Crescent) — Ready November 2025

- 2 shared houses: 5 people can live in each one – all bedrooms are ensuite with large living areas.
- 6 flats: for single occupancy plus ground floor communal space.



Cobham (Anyards Road) - Ready January 2026.

- Block A = 6 flats: for single occupancy plus ground floor communal space.
- Block B = 6 flats: for single occupancy plus ground floor communal space.

Care and Support for the new services.

Housing development.

We have created an Easy Read guide to Tenancy Agreements so people can understand their rights.



Housing Development.

We are also working with colleagues in the District and Borough Councils and Social Care Teams to make sure that general needs housing is accessible to disabled people.



Autism training has been delivered to the Housing Teams at three District & Borough Councils in Surrey.



There are monthly advice sessions for Social Care staff to help them support people who are having housing issues.



Travel Policy.

The Travel Policy has been signed off by Cabinet and is published. The policy will:

- Ensure consistent decision making
- Support residents understanding of how decisions are made and what is available to them to support independent travel
- Centre
- Travel Training Pilot has run in partnership with Surrey Choices and we have trained 45 individuals so far.



All-Age Autism Strategy 2021-26.

Working to get rid of inequalities for autistic people in education, health, social care, work and communities.

You Said, We Did, What's Next?

We have published a report explaining the progress we have made with the strategy.

- Most people felt we had made progress, but some disagree
- Most people thought the future plans were good, but some disagree

There is a lot more work to do. We need to keep involving autistic people. We want the changes to work for everyone.



Everyday Living Opportunities.

We have completed market engagement sessions with the provider market. There are 4 models of support:

- Community and life skills
- Centre based support
- Supported Employment
- Travel Training



We are now working through the legal processes required for us to tender services.

New Supported Living Services.



Gaynor Gibbins asked if the new services being built are close to local amenities such as shops and bus stops.

Mary Hendrick explained that the Cobham site is 5 to 10 minutes walk from local amenities and that the Byfleet site is further away,

New Supported Living Services.



The properties will be owned by Surrey County Council, who will be the tenant's landlord. We are currently recruiting care and support providers for each service,

Helen Hunt was asked about the size of the apartments and bedrooms. Helen reported that the apartments are between 54.8m2 and 64.2m2 with the larger flats classed as M4(3) 'wheelchair user dwellings'. Bedrooms in the townhouses are between 30.4m2 and 35m2

Helen Hunt explained that if tenants need sleep in staff there is room in the new buildings for staff to sleep over.

The new supported living buildings cost £20 million and the new short break buildings £5 million.

Providers Unite.

There will be further protests, and Providers Unite are campaigning for care providers to be exempt from the rise in Employers National Insurance contributions.

Providers are very concerned that these extra costs could cause some providers to go out of business and are communicating these concerns to the Government.
