

**SURREY COUNTY COUNCIL
AMENDMENTS TO WAITING AND LOADING RESTRICTIONS
AND ON-STREET PARKING PLACES IN THE BOROUGH OF WOKING**

ON 6 SEPTEMBER 2019 SURREY COUNTY COUNCIL PROPOSED TO MAKE The Surrey County Council (Various Roads in Woking) (Amendment of Waiting Loading and Unloading Prohibition and On-Street Parking Places Orders) (Amendment No. 1) Order 202-, pursuant to Sections 1, 2, 4, 32, 35, 36 and 45 to 53 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984. The purpose and effect of which is to amend the following Orders:- (1) The Surrey County Council Woking Controlled Parking Zone (Revocation and Consolidation of Waiting Restrictions and On-Street Parking Places) Order 2019; (2) The Surrey County Council (Various Roads in Woking) (Revocation and Consolidation of Waiting Loading and Unloading Prohibition and Restriction) Order 2019; (3) The Surrey County Council (Various Roads in Woking) (Consolidation of Free Street Parking Places and Revocation) Order 2019; (4) The Surrey County Council West Byfleet Controlled Parking Zone in the Borough of Woking (Revocation and Consolidation of Waiting Restrictions and On-Street Parking Places) Order 2019; (5) The Surrey County Council Brookwood Controlled Parking Zone in the Borough of Woking (Revocation and Consolidation of Waiting Restrictions and On-Street Parking Places) Order 2019; (6) The Surrey County Council (Various Roads in Woking) (Consolidation and Revocation of Free Street Parking Places) (Disabled Persons) Order 2019; (7) The Surrey County Council (Various Roads in the Borough of Woking) (Prohibition of Stopping Outside Schools) Order 2019; (8) The Surrey County Council Various Roads in the Borough of Woking (Residents' On-Street Parking Places) Order 2019; (9) The Surrey County Council (Borough of Woking) Free On-Street Parking Places (Police Vehicles) Order 2019; (10) The Surrey County Council (Borough of Woking) (Bus Parking Places and Revocation) Order 2019; (11) The Surrey County Council (Various Roads in Woking) (Consolidation of Loading bays and Revocation) Order 2019; (12) The Surrey County Council Various Roads in the Borough of Woking (On-Street Car Club Parking Places) Order 2019. The Council now proposes to make further amendments to the said orders, so as to:-

- (a) Prohibit waiting by vehicles in certain lengths of the roads specified in the First Schedule to this Notice, on the days and at the times indicated in the said Schedule;
- (b) Exemptions for loading on and unloading from vehicles, boarding and alighting from vehicles, using vehicles for works on or adjoining the lengths of roads referred to in the First Schedule, the maintenance of those roads and the services in them and for disabled persons' vehicles in accordance with the Blue Badge Scheme, will apply to the afore-mentioned restrictions;
- (c) Provide that there be a restriction from loading on and unloading from vehicles in certain lengths of Kingfield Road and Beaconsfield Road, Kingfield, from Monday-Friday 8.15am-9.15am and 2.30pm-4pm, subject to the usual exceptions, e. g. for works on or adjoining the said lengths of roads, the maintenance of those roads and the services in them and for emergency service vehicles etc.;
- (d) Revoke such at any time waiting restriction in a certain length of Monument Way East, Woking, without replacement;
- (e) Provide such free on-street parking places in certain lengths of the roads specified in the Second Schedule to this Notice to operate at the times and with such limitations as specified therein;
- (f) Specify that the vehicles which may be left in such free on-street parking places shall be passenger vehicles (8 seats or less), motor cycles, invalid carriages and goods vehicles;
- (g) Provide such residents' parking places in certain lengths of roads in the Third Schedule to this Notice, for use by valid permit holders within the appropriate zone, operational on the days and at the times specified therein;
- (h) Provide such dual use voucher/permit parking places in certain lengths of the roads as are specified in the Fourth Schedule to this Notice; for use at the times and on the days specified in the said Schedule, for use by such vehicles as specified in subparagraph (2)(f) above or valid permit holders for appropriate area within the Woking Controlled Parking Zone (CPZ);

- (i) Provide that vehicles left by specified disabled persons may wait in the on-street parking places referred to above, at all times without time limit;
- (j) Provide disabled persons' parking places in certain lengths of the roads specified in the Fifth Schedule to this Notice operational at all times without limit of time;
- (k) Revoke a disabled persons' parking place in St. Peter's Close, Old Woking;
- (l) Provide that certain other vehicles may wait in the on-street parking places described above in certain circumstances e.g. to allow persons to board or alight (maximum 2 minutes), to load or unload (maximum 20 minutes), etc.;
- (m) Provide that in the case of any of the on-street parking places specified above, outside the hours of operation indicated in the said Schedules, any vehicle may be left in any of those on-street parking places for any period without time limit;
- (n) Prohibit the stopping of vehicles outside schools, in a certain lengths of Chobham Road, Knaphill, between 8.15am-9.15am and 2.30pm-4pm every day as indicated by zig-zag markings on site (which will be slightly shorter than the existing waiting restrictions applying at the same time, which will be revoked);
- (o) The usual exemptions shall apply, namely any person causing a vehicle to stop in order to avoid an accident if required to do so by law; anything done with the permission of a police constable in uniform or in accordance with a sign placed by Surrey Police in accordance with Section 66 or 67 of the Act; or any vehicle which is displaying a valid waiver certificate issued by the Council;
- (p) Introduce such on-street parking places for the parking of a car club vehicle only which displays a valid car club permit. The car club bays will be in operation for 24 hours, Monday to Sunday in certain lengths of Chertsey Road, Woking, subject to the usual exemptions e.g. emergency vehicles, using vehicles for works on or adjoining those lengths of roads etc., (n. b. disabled "blue badge holders" will not be exempt from these restrictions).
- (q) Where a restriction is proposed herein any existing restriction on the same length of road will be revoked;
- (r) Make provision for virtual permits for all permit schemes in the Borough.
