

Surrey County Council
Proposed Amendments to The Controlled Parking Zone in the Borough of Guildford

NOTICE IS HEREBY GIVEN that Surrey County Council proposes to make an Order under Sections 1(1), 2(1) to 3 and 4, 32, 35, 36, 45, 46, 49, 51 and 53 and Parts III and IV of Schedule 9 to the Road Traffic Regulation Act 1984 ('the Act') the effect of which will be to further amend "The Surrey County Council Various Roads in the Borough of Guildford (Guildford Town Centre Controlled Parking Zone) (Consolidation of Waiting and Loading Restrictions and Street Parking Places and Revocation) Order 2009". The Order, to be known as "The Surrey County Council Various Roads in the Borough of Guildford (Guildford Town Centre Controlled Parking Zone) (Consolidation of Waiting and Loading Restrictions Street Parking Places and Revocation) Amendment Order (No. _) 20__" which proposes to make the changes as described below.

The general purpose and effect of the Order will be to:

- (a) amend and revoke some of the existing parking controls,
- (b) increase the maximum stay from 2 hours to 3 hours in the existing pay and display only parking place in Millmead, (Note - all the existing time limits (except as provided above), charges and conditions of use will remain without change),
- (c) introduce No Waiting At Any Time double yellow lines,
- (d) convert some existing shared use parking space to permit only parking spaces,
- (e) convert existing No Waiting At Any Time to Permit Holders Only parking spaces,
- (f) Introduce various formalised Blue Badge Holders (Disabled Persons) Only Parking Places
- (g) In respect to paragraphs (d) to (f) above, vehicles displaying a disabled persons "Blue Badge" may wait in those parking places free of charge and without time limit.
- (h) In respect to paragraphs (d) to (f) above, any vehicle may wait in those parking places for the purposes of boarding and alighting (for a period not exceeding two minutes), or for the purposes of loading / unloading goods (for a period not exceeding twenty minutes)
- (i) in respect of the proposed No Waiting Restrictions referred to above, provide that the usual exemptions in respect of loading and unloading vehicles, boarding and alighting from vehicles, using vehicles for works on or adjoining the affected lengths of roads, the maintenance of those roads and the services in them and for disabled persons' vehicles in accordance with the "Blue Badge" Scheme would apply;
- (j) Make certain drafting amendments to The Surrey County Council Various Roads in the Borough of Guildford (Guildford Town Centre Controlled Parking Zone) (Consolidation of Waiting and Loading Restrictions and Street Parking Places and Revocation) Order 2009 ("the Order of 2009") (as amended) which will not affect any of the measures introduced by that order, except for those provided above in this notice.

CONVERT EXISTING 8.30 – 9PM PAY AND DISPLAY MAX STAY 2 HOURS to 8.30-9PM PAY AND DISPLAY MAX STAY 3 HOURS

Millmead (*In the centre of the carriageway from 12m North of the entrance to Porridge Pot Alley to 8m East of the Northern boundary of the Guildford Baptist Church*)

CONVERT EXISTING 8.30 – 9PM LIMITED WAITING 2 HOURS NO RETURN WITHIN 1 HOUR OR PERMIT A HOLDERS ONLY TO PERMIT A HOLDERS ONLY

Springfield Road (*Various lengths both sides from 10m to 23m North of its junction with York Road*)

Foxenden Road (*Various lengths both sides from 10m to 23m North of its junction with York Road*)

Falcon Road (*Various lengths both sides from 10m to 23m North of its junction with York Road*)

Victoria Road (*Various lengths both sides from 10m to 25m North of its junction with York Road*)

**CONVERT EXISTING FREE PARKING PLACE TO MON-SAT 8.30 – 6PM MAX STAY 4 HOURS
NO RETURN WITHIN 1 HOUR OR PERMIT HOLDERS J ONLY**

Wilderness Road (*Various lengths on the East side from 53m North of its junction with Ellis Avenue to 66m Northwest of its junction with The Crossways*)

**CONVERT EXISTING MON – SAT 8.30 – 6PM LIMITED WAITING 2 HOURS NO RETURN WITHIN
1 HOUR TO NO WAITING AT ANY TIME DOUBLE YELLOW LINES**

Josephs Road (*On the North side from 50m to 85m West from its junction with Langley Close*)

IMPLEMENT ADDITIONAL NO WAITING AT ANY TIME DOUBLE YELLOW LINES

St Bartholomew's Court (*Various length both sides from its junction with St Catherine's Park to 30m Southwest thereof*)

St Catherine's Park (*On the North side from 10m to 20m Southeast of its junction with St Luke's Square*)

St Luke's Square (*Various lengths on the garden side of the square from 5m of the Northern corner to 5m from the southern corner of the square*)

**CONVERT EXISTING NO WAITING AT ANY TIME TO PERMIT D HOLDERS ONLY PARKING
PLACE**

Quarry Street (*On the West side from 20m to 35m Southeast of its junction with Castle Street*)

**CONVERT EXISTING LIMITED WAITING 2 HOURS NO RETURN WITHIN 1 HOUR MON-SAT
8.30-6PM TO BLUE BADGE HOLDERS ONLY PARKING PLACE**

Cooper Road (*From 10m to 16.6m West of its junction with Cline Road*)

West Road (*From 10m to 16.6m Southwest of its junction with Waterden Road*)

**CONVERT PART OF EXISTING PERMIT HOLDERS A ONLY 8.30AM – 9PM TO BLUE BADGE
HOLDERS ONLY PARKING PLACE**

Artillery Terrace (*On the South side from 14m to 26.6m East of its junction with Artillery Terrace*)

Artillery Terrace (*On the East side from 10m to 14m East of its junction with Artillery Terrace*)

Gardner Road (*On the north side from 18.6m to 12m West of the end of the road*)

**CONVERT PART OF EXISTING LIMITED WAITING 4 HOURS NO RETURN WITHIN 1 HOUR OR
PERMIT J HOLDERS ONLY TO BLUE BADGE HOLDERS ONLY PARKING PLACE**

The Crossways (*On the south side from 36m to 42.6m East of its junction with The Crossways*)

**CONVERT PART OF EXISTING LIMITED WAITING 2 HOURS NO RETURN WITHIN 1 HOUR OR
PERMIT E HOLDERS ONLY TO BLUE BADGE HOLDERS ONLY PARKING PLACE**

Stocton Road (*On the North side from 45m to 52.6m East of its junction with Stocton Close*)

**CONVERT PART OF EXISTING LIMITED WAITING 8.30 – 9PM 2 HOURS NO RETURN WITHIN 1
HOUR OR PERMIT HOLDERS B TO BLUE BADGE HOLDERS ONLY PARKING PLACE**

Guildford Park Avenue (*On the north side from 27m to 33.5m East of the entrance with the garages*)

Denzil Road (*On the East side from 26m to 32.6m southeast of its junction with Guildford Park Road*)

**CONVERT EXISTING BLUE BADGE HOLDERS ONLY PARKING PLACE TO PERMIT J
HOLDERS ONLY**

Litchfield Way (*On the Northern side from 2m to 8.6m West of its junction with Vicarage Gate*)

**CONVERT EXISTING LIMITED WAITING MON - SAT 8.30 - 6PM OR PERMIT HOLDERS F
PARKING PLACE TO NO WAITING MON - SAT 8.30-6PM SINGLE YELLOW LINES**

Wodeland Avenue (*On the East side from 85m to 96m West of its junction with Wherwell Road*)

**CONVERT EXISTING PERMIT HOLDERS B ONLY TO NO WAITING AT ANY TIME DOUBLE
YELLOW LINES**

Millmead Terrace (*On the West side from 67m to 72m North from the Southern corner of Millmead Terrace*)

ALLOW FOR THE INTRODUCTION OF NEW ON STREET PEDAL CYCLE PARKING PLACES
