## Jo updated us about the co-production of the new Carer Breaks Offer.

#### Key findings from our co-design.

A company called Luminous lead the co-design. 550 carers completed a survey, and we held 13 focus group events.

#### **Key findings:**

- Carers did not always understand our preventative offer of 35 hours of free short breaks.
- The current offer of 35 hours short breaks was not seen as enough.



35 hours

If a carer needs more than 35 hours of short breaks they would need to have a carers assessment from Surrey County Council.

#### Key findings from our co-design.

 A range of respite options needed to meet the needs of carers of people with dementia, learning disabilities, mental health, parents of children and young adults and autistic people.



 Greater flexibility of offer needed (breaks at weekends, evenings and different times of the day).



 Carers felt the Care Act assessment needed to be earlier in the process (to identify ongoing need sooner). Rather than offer 35 hours and then offer an assessment some people would need an assessment at the start of the process.



#### Carers criteria for the new breaks offer.

Early information and good communication.



 A clear idea of the process from start to finish and different options for people with different needs. A menu of different options.



#### Carers criteria for the new breaks offer.

 Helping people to identify themselves as a carer- some people do not realise that they are a carer.



 Clear information about what happens after a person has used the carers breaks offer.



 The process should not cause carers more stress.



Surrey County Council are reviewing the feedback from carers and will agree a new carer breaks offer.

#### Carer Innovation Fund.

The fund started in April 2022 and offers one-off Better Care Fund (BCF) grants.



These grants are to start or grow innovative projects to support unpaid carers improve their health and wellbeing.



In 2 years £416,229 from the Carers Innovation Fund has invested in new projects which benefit 3000 carers.

Some pilot projects have been very successful and have been given ongoing funding from commissioners.

Projects have included support for carers to fill in forms and claim the benefits they are entitled to.





## Adults Wellbeing and Health Partnerships Transformation – Internal Programmes.

- Jo Neville-Rye explained that another round of the Carers Innovation Fund bidding was about to open in July 2024.
- She also explained that this July 2024 round was not focused on specific client groups, but there would be a further round opening in September 2024 which would be targeted to specific client groups.

## Safeguarding and Quality Assurance.

The Learning Disability and Autism Team.

### The Learning Disability and Autism Team are split into 3 teams.



 These teams are East, West and the SIRT (Supporting Independence and Reviewing Team) team.



The teams cover very large parts of Surrey.

Aaron Ketley-James covers the team in East Surrey and Kim Raif covers the team in West Surrey.

#### **Common Safeguarding Themes.**



#### Medication Errors.

Some care homes report all their medication Safeguarding's at the end of month. So we do get a batch of medication errors in one go.

#### **Common Safeguarding Themes.**



#### **Accidental Safeguarding Reports.**

Sometimes people report something as safeguarding when it is not, this is usually by accident.



#### **Domestic Abuse.**

We have noticed the Police are reporting more Domestic Abuse to the team.



There are a series of Easy Read booklets to keep people safe from abuse, including a booklet on Domestic Abuse.

#### People living together.

In some care homes not all the people always get on and sometimes hit each other.

#### Care Services who need extra support.

Some care services need extra support using 'provider support process'.

This is when Surrey have extra meetings with the service to help them learn more about safeguarding and help prevent abuse and/or neglect happening.

We currently have 6 services in this process.

This is a big piece of work for all agencies supporting the services.

The TransitionTeam will have a new Safeguarding Advisor called Kimberley Gerrard soon.



#### **Quality Assurance**

Quality Assurance now have 2 workers who work within the learning disability and autism service.

They visit services and share good practice to make sure that the support we offer in Surrey is the best quality. They are keen to work with people who use services to be Quality Checkers.

How emergency services support people with a learning disability.

#### Short Breaks.



#### Mary Hendrick updated us.

'Short Breaks' can be any support that enables a person to take a break from the responsibilities of caring.

#### **Short Breaks.**

Short breaks can be anything from a few hours to longer periods of time.

- Short Breaks may be planned in advance or be needed at short notice.
- There are a range of different types of services which can provide this.
- A short break should be responsive to people using the services, the circumstances of parent/family carers and should be reliable.
- Eligibility for short breaks in Surrey is determined by Care Act (2014) compliant carers assessment.







#### **Surrey County Council Cabinet Paper March 2023.**



The Surrey County Council Cabinet agreed with our plans for short breaks in Surrey.

Our plan means that we will more than double short break services in Surrey.

Our aim is to promote Carers wellbeing and give them a break, and to enable people to remain in their family homes and connected to their local community by developing a range of opportunities.

We are building two brand new short break services in Surrey. One will be in Woking, the other in Banstead.

They will be very modern and have rooms with hoists, shared kitchens and living rooms, sensory rooms, and outside areas which include a trampoline. By January 2025 we plan to start building work at Banstead and for the building work to be completed at Woking.

Our proposal is to re-model our short breaks offer to work with providers to ensure we have a more diverse short breaks offer, giving people more choice.

Continuing working with our current providers to ensure meeting needs of individuals.

Community Opportunity Everyday Living will include a mini competition that looks at outreach short breaks.

Will develop information on types of offer, available and how access short breaks for carers.

Work with property to ensure new builds developed on time.

A family carer commented that they had had no respite for 6 years, and no social worker since their daughter left college.

Paying for care.



A family carer told us how their bill for Short Breaks went up from £100 a month to more than £200.

Mary Hendrick said that it was important that carers were charged the correct amount for the breaks they use, and that carers should ask the Income and Assessment Board to review any charges they don't feel are accurate.

Mary Hendrick agreed to make sure carers have up-to-date information about the Surrey County Council Charging Policy.
