

Jane asked how the Autism Partnership Board links to the Learning Disability Partnership Board as many people with a learning disability are also autistic.

Mary Hendrick explained that there is a separate All Age Autism Strategy to engage with the wider community, as there are a lot of autistic people who don't have a learning disability.

## Partnership Board members questions and comments about our 2024 Workplan

Older people.



Mary Hendrick said that the oldest person with a learning disability supported by Surrey County Council is 96. People are living much longer, we need to make sure older people with disabilities are considered in planning.

Gaynor Gibbins said people with Downs Syndrome can get dementia earlier, would be good to have someone on the board representing these people. Steve Denman said that his daughter has Downs Syndrome although she is only 40.

#### Carers Partnership Board.



Anna Waterman said there is a separate carers partnership board and we need to make sure there is a good link between this and our board. Carers are on the work plan in June.

In addition to these plans, we may want an additional meeting as we go through the year. If people are happy with this we will update our workplan on the website so people know what we have planned.

# Experts by Experience with Surrey People's Group



Amanda Aldridge and Carinder Malhi updated us.

The Surrey People's Groups event on the 8<sup>th</sup> December discussed Travel and Transport. About 50 people came to the event.

Surrey People's Group have developed a Taxi Charter

#### How we are using the charter.



Sending it out to people so they can try and get their local taxi companies to sign up.

Talking to Trading Standards about whether there are any standards for taxi companies.

Looking at disability awareness training for Surrey taxi licences as in Sussex they have to do this.

Sharing the taxi charter with Surrey Council taxi people.

## Marnie Cotterill told people about the Adult Social Care Transport Policy.

## We talked about issues people with learning disabilities can find difficult.

 Timetables are hard to read and bus apps can be confusing



 Bus drivers can be rude and hard to talk to, and can drive away before you have sat down



 Not given information about delays, and in some places there are no buses when needed





Most people did not know about companion passes.



 People worry about getting lost, and what to do if things change



 People who had done travel training felt more confident



## We asked people if they could travel independently, where would they like to go?

- Different towns, not just locally
- Seaside



 Have a choice and visit different places





#### What makes it hard to use public transport?

#### As well as things people mentioned on page 10 people also said:

- Want to use cash but will only take a card
- Cannot get a bus pass



- Not enough space for wheelchairs
- Wheelchair users not supported
- · Ramp not lowered for wheelchair







#### **Community Transport**



Some people knew about this, some thought it was only for older people.

Difficult to book and pay for.





Have to book in advance so no good at short notice.



Doesn't run in the evening so doesn't support a social life.



## How was travel support affected when moving from children to adult services?

Able to keep travel support / still eligible.



Had several assessments for transport.

Would like more easy read information relating to travel, and would like an easy-to-use app.



Would like travel training when younger.



#### **Bus Charter**


Keith McKain wanted to know what people thought and will tell the Surrey bus stakeholder group what people said.





Most people had not seen the charter before. People thought it was helpful.

#### Good things people said about using buses



Mostly good experience

Good value and valuable services

Kind driver, bus came on time, clean and warm

Felt safe.







## Other things people said that are bad about using buses which we haven't said before



Drivers arguing about disability – lanyard should be enough



Other passengers not helping



Too many buggies in the way and crying babies



Kicked by school kids



Bus did not stop when signalled, and no information on the bus to indicate the next stop



Find it hard to know what ticket to buy £2 bus cap inconsistent





Bus passes should be valid before 9.30 or discount should be the same on all buses



Bus stops not always seem clean



#### Other things people said that about travel.

Mary Hendrick said that she worked with a group of people from Surrey Choices who had a lot of very important things to say.



At lunch time Lawrie Baker from Active Surrey came along with the smoothie bike. They have made links with Travel Training to ensure that cycling is considered as an option.



Helen Guest fed back that some people from Proactive community that had not been before enjoyed it and found it very useful.

#### We have talked with group members



We did a survey of the groups in November 2023 and put together suggested actions.



We agreed way forward with co-chairs, and made plans for 2024

Encourage more people with a learning disability and carers to get involved.



Guidance for presenters – no jargon, images

#### Things we agreed





Local hybrid meetings. Meetings that are in person, but also online using Teams.





Have a theme for each meeting and a focus on local issues such as social activity in North-West Surrey.



There will be a clear link to and from Partnership Board, so that local issues can be heard.



We will relaunch the groups to encourage new members to join.

Gaynor said she felt it was slightly selfish of professionals to not be prepared to come along in person. Joyce said she thought hybrid meeting are good for lots of people but she liked in person better as you don't get body language, etc. She stressed that the important thing is to engage people and in find out what they want. Need to be proactive.

We are continuing with hybrid meetings as some people are still worried about going out and about.

## The Surrey Learning Disabilities and Autism Joint Commissioning Committee.

What is the Surrey Learning Disabilities and Autism Joint Commissioning Committee for?



The committee will make sure there is an agreed long-term plan of supporting people with complex learning disabilities and / or behaviours that can challenge services.





Some services will be commissioned by Surrey County Council and some by Surrey Heartlands. Services will help people who need them whoever commissions them.

#### What are the aims of the committee?



Work out what stops people leaving long stay hospitals and how to solve this.

#### What are the aims of the committee?



Develop a community wraparound service to stop people going into hospital when they don't need to.



Set up an all-age joint Dynamic Support Register so people get intensive support when they need it.



Look at ways that funding is agreed and what causes problems. Think of ways to make this better and tell the Program Board.



Make sure that specialist services for people who have been convicted of a crime are connected with mainstream services.



To make sure there are smooth pathways for people moving from children to adult services.



To think about ways to help providers with things that they are all finding difficult.



To make sure that the work is done through coproduction with experts from experience.

 It's local, and helping out by volunteering and support to bet a job



 There's not enough autism training for employers, and support for them to make reasonable adjustments





 More travel training needs to be available when needed. Learning one journey doesn't mean you're independent. Some people will still need support to learn the next journey.




#### Key themes we are working on:

## Questions and comments about The Surrey Learning Disabilities and Autism Joint Commissioning Committee.



Helen Guest asked if wrap around would be in a local area hub or home based 1:1.

Anna Waterman said it could be either. Want to look at what is needed in the persons local community.

Maria Mills asked what about innovation and supporting external bids. How will you get feedback about what is working. Maria also said that sometimes there are opportunities to get external funding in for Surrey people.

Anna Waterman said they need to think about ways to support providers, need to include innovation and continuous improvement.

Reza Sharmtally said he was at the meeting, and he mentioned that he feels there should be representation from children and education.

Anna said there has been quite a lot of joint work between children and health. For the first year the meeting will focus on adults and include transition. In future will work more closely with colleagues from education.

Maria Mills said some statutory organisations are also providers, why can't more voluntary sector organisations be involved.

Anna Waterman said Surrey Care Association was representing providers for now but will consider in future.

## Questions and comments about Community Opportunities for Everyday Living.



Christina Earl asked whether there will be separate lots for different things.

Tom Moore said yes but still unsure what form they will take at the moment.

Mary asked if when the market engagement events happen, we can make sure we involve smaller organisations too.

Anna Waterman said all the information about market engagement will come out through Idcommunications.

Joyce Smith said she is not hopeful when she sees the length of time it will take to complete this work. She said the manager at the café for ALDAG in Dorking is working so many hours as they can't get a manager.

Jerry Ratcliff said he will get in touch with Joyce and see if he can help with recruiting a manager.



Sally Dubery said there are lot of smaller voluntary sector organisations that would like to be involved but have limited capacity. Would be good to give thought to how to support them to be part of this such as times of meetings.

Tom will discuss this with Sally.

Joyce Smith said someone she knows needs more support and asked if there is any way they could get more support.

Mary Hendrick said she will talk to Joyce about this outside of the meeting.



We are reviewing the inequalities and cancer screening outcomes for adults with a learning disability, and working closely with Public Health and Government co-producing the Downs Syndrome Act 'I statements'.
