He explained about getting a wheelchair, getting one fixed and how to raise a concern or complaint.




He told us that Roscare are getting someone trained in Easy read so they can do easy ready information.

Provide local information to the partnership board and to pass on information through their networks.




To share information about the development of local services.

Discussion



David said he only found out the meeting was on Teams last week. Amanda explained why and offered to support David outside of the meeting. Dexter said Surrey Choices have also switched to Teams.













Tony said he is involved with some work on fraud and the law that he would like to link with the group.

David said he had a lot of difficulty finding out information from Waverley Borough Council. He would like to introduce a more campaigning approach as vice chair of the Independent Mental Health Network.

Carinder said it made sense for the Valuing People Groups to work together when they have the same concerns.

Tony suggested inviting local teams and Alzheimer's groups to the meeting.

Tony said he has done part of the Oliver McGowan training. Tom explained that Liz Williams was leading on this in Surrey, and she will be asked to update the Learning Disability Partnership Board.

Discussion



Tom asked if this is open to adults of all ages. Lisa said it was and that referrals should be made through Social Workers.





Chris said it was a great new service.

Tony said it was good to hear about Surrey helping people with journeys. He said that signage is very important, especially when there are less frequent buses. Tony asked what would happen if a bus did not stop for someone.






Lisa said they would have a contingency plan, so people knew what to do if something goes wrong. Tony asked for a copy of the assessment form. Lisa will send via Amanda.

There is a speaker coming to talk about buses at the Learning Disability Partnership Board and Surrey People's Group in December is about travel and transport.





David said he had difficulty getting his mobility scooter on buses. Tom agreed this is an important point.



Carinder said that having a disability card can help with buses and you can bring a companion. He is going to apply for the travel training service.

Active Travel Scheme

Roger Williams and Andy Mills came to talk about the London Rd, Burpham Active Travel Scheme.

Key Points

Aims of the project:



Safer roads



- Better access for children, people walking and cyclists
- Make Guildford a greener place

What is happening:



- Installing one way cycle paths on both sides of London Road.
- Safer crossing for people and cyclists at roundabouts.
- New crossing points
- Better junctions
- Making bus stops better





There's lots of information about this scheme on the Surrey County Council website.



There is a <u>survey</u> and further information including a video.

Discussion



Carinder suggested linking with Surrey Choices, Andy said he has a connection with them.



Chris said he thought it was a great idea but there would be challenges about compliance such as people not leaving cycle routes clear. Andy said behaviour change takes time and education is necessary.



Accessible signage was raised as important.



David raised the difficulty of trees hiding bus stop signage. Andy said he is aware of the need to keep on top of maintenance of existing infrastructure.



Tom spoke about the positive impact of a similar scheme where he lives and how it has the potential to make the whole area more accessible.



Tony said it is brilliant work as a pilot and he welcomed the discussion with local people but how it feeds into maintenance and enforcement is important.



Roger said they inspect the entire road network on a regular basis. If private, owners are asked to cut back but they may need to use enforcement which takes time. He asked people to report any problems via the contact centre.



They want to listen to residents and asked the group to do the survey and / or contact them with any further points.

Discussion



Tony questioned why only 20 people had been asked for their feedback. Chris said it was 230, not 20.

Tony asked how the council would be held accountable for this work. Chris explained there was a work program set out for the next 5 years and a program board that includes people with lived experience that will oversee this work.



Gemma Hare asked about recruitment of PA's as she knew of someone who is struggling to find them. Chris said they are looking again at rates of pay and recruitment and have run campaigns recently.
