

Surrey County Council
Amendments to Waiting and Loading Restrictions
And On-Street Parking Places in the Borough of Epsom and Ewell

On 27 February 2024 Surrey County Council made, with modifications, certain amendments to the waiting and parking restrictions in the Borough of Epsom and Ewell pursuant to Sections 1, 2, 3, 4, 32, 35, 36, 45, 46, 49, 51 and 53 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984: -

1. Make “The Surrey County Council (Various Roads in Epsom and Ewell) Amendment of Waiting Loading and Unloading Prohibition and On-Street Parking Places Orders) (Amendment No.8) Order 202-”. The purpose of which is to: -

(1) Amend “The Surrey County Council (Various Roads in Epsom and Ewell) (Revocation and Consolidation of Waiting, Loading and Unloading Prohibition and Restriction) Order 2018” so as to: -

(a) prohibit waiting by vehicles in certain lengths of the roads specified in the First Schedule to this Notice, on the days and at the times indicated in the said Schedule;

(b) provide that exemptions for loading on and unloading from vehicles, boarding, and alighting from vehicles, using vehicles for works on or adjoining the lengths of roads referred to in the First Schedule, the maintenance of those roads and the services in them and for disabled persons’ vehicles in accordance with the Blue Badge Scheme, will apply to the afore-mentioned restrictions;

(c) revoke the existing waiting restrictions in part in certain lengths of roads specified in the Second Schedule to this Notice, to support what is currently on the ground, during the times and on the days specified in the said Schedule without replacement.

(2) Amend “The Surrey County Council (Various Roads in Epsom and Ewell) (Consolidation and Revocation of Free Street Parking Places) (Disabled Persons) Order 2018” so as to: -

(a) provide such free disabled persons on-street parking place in the lengths of roads specified in Third Schedule to this Notice, during the times and on the days specified on the said Schedule;

- (b) provide that certain other vehicles may wait in the on-street parking places described in part (e) above in certain circumstances e.g. to allow persons to board or alight (maximum 2 minutes), to load or unload (maximum 20 minutes), etc.;
- (3) Amend “The Surrey County Council (Various Roads in Epsom and Ewell) (Consolidation of Free Street Parking Places and Revocation) Order 2018” so as to: provide such free on-street parking places in Stoneleigh Broadway and Station Approach, Stoneleigh, to operate Monday to Saturday 8.30am - 8pm 10 minutes only, no return within 1 hour, commonly known as “kiss and ride” parking places;
- (4) Amend “The Surrey County Council (Various Roads in Epsom and Ewell) (Consolidation and Revocation of Prohibition of Stopping Outside Schools) Order 2018” so as to: -
 - (a) prohibit the stopping of vehicles outside schools, as indicated by zig-zag markings on site, in a certain length of Waverley Road, Stoneleigh, applying Monday to Friday (inclusive) between 8.15am and 9.15am and between 2.30pm and 4pm.
 - (b) provide that the usual exemptions shall apply, namely any person causing a vehicle to stop in order to avoid an accident if required to do so by law; anything done with the permission of a police constable in uniform or in accordance with a sign placed by Surrey Police in accordance with Section 66 or 67 of the Act; or any vehicle which is displaying a valid waiver certificate issued by the Council;
- (5) Amend “The Surrey County Council Various Roads in The Borough of Epsom and Ewell (Consolidation of Permit Holders Only) (On-Street Parking Places) Order 2018” so as to: -
 - (a) revoke the southeasternmost parking bay outside No.168 Ewell By-Pass without replacement;
 - (b) introduce on-street residents’ only parking places in a certain length of Kingston Road, Ewell with the letter identifier “EE” to operate Monday to Saturday (inclusive) 8.30am to 6.30pm. The residents that may be eligible to apply for parking permits will be property Nos. 1-9 Ernest Cottages (inclusive) and No.66 Kingston Road. The following provision will apply: -

- (i) the vehicles which may be left in the parking place, during the hours of operation shall be vehicles displaying a valid parking permit bearing the appropriate identifying letter;
 - (ii) provide residents' parking permits for residents of the said properties, which will allow them to park in the said on-street permit holders' only parking place during the hours of operation. Such permits will cost £80 for the first permit, £100 for a second permit and £130 for any subsequent permit (as applicable) and will be valid for a period of twelve months. These charges will rise by £4 on the 1st of January on each of 2024, 2026, and 2028. The charge for a duplicate permit or a change of permit due to the change of vehicle will be £15;
 - (iii) provide that such residents parking permits shall be allocated using the following calculation: the sum of the number of vehicles registered to the place of abode minus the number of off-street parking places for such place of abode;
 - (iv) provide for: (1) residents to purchase permits for use by their visitors at a cost of £2 each, which will be valid for one day, subject to a limit of 150 pa, or £1 which will be valid for 2 hours limited to 250 pa; (2) Operational Permits, for use by doctors and nurses, and Carers Permits, for carers and community care personnel who are required to make visits to residents, which will be free of charge; and (3) Child Care Permits, for persons employed to visit a resident for the purpose of child care, pursuant to a contract of employment, will incur the same cost as a resident's permit, dependant on how many permits the resident has already been issued.
- (c) introduce on-street residents' only parking places in a certain length of Kingston Road, Ewell with the letter identifier "FF" to operate Monday to Saturday (inclusive) 8.30am to 6.30pm. The residents that may be eligible to apply for parking permits will be property No's 44, 44a, 46, 48, 50, 52, and 54, Kingston Road, Ewell. The costs and conditions of use will be the same as in sub-paragraphs (5)(b)(i) to (5)(b)(iv) above;
- (d) include the residents of No.26 Church Street, Epsom to be eligible for permits in Permit Parking Zone "K". The costs and conditions of use will be the same as in sub-paragraphs (5)(b)(i) to (5)(b)(iv) above;

(e) include the residents of No.47A Church Street, Epsom to be eligible for permits in Permit Parking Zone “M”. The costs and conditions of use will be the same as in sub-paragraphs (5)(b)(i) to (5)(b)(iv) above;

(6) Amend “The Surrey County Council Hookfield and Lindsay Close Controlled Parking Zone in The Borough of Epsom and Ewell (Consolidation of Waiting Restrictions and On-Street Parking Places) Order 2018” so as to revoke the parking bay outside No.125 Hookfield, Epsom to be replaced with a single yellow line, operational on the days and at the times specified in the First Schedule to this Notice;

2. Make certain drafting amendments to the following existing Orders which impose waiting, loading, and unloading and parking prohibitions and restrictions in the Borough of Woking, which will not affect the operation of those prohibitions and restrictions: -

(1) The Surrey County Council (Various Roads in Epsom and Ewell) (Consolidation of Free On-Street Loading Bays and Goods Vehicles’ Free On-Street Loading Bays) Order 2018;

(2) The Surrey County Council (Various Roads in Epsom and Ewell) Electric Vehicle Parking Places Order 2023; and

(3) The Surrey County Council Various Roads in the Borough of Epsom and Ewell (On-Street Car Club Parking Places) Order 2023;

3. Make “The Surrey County Council (Epsom and Ewell Prohibition of Verge Parking) Order 2014 (Amendment No.3) Order 202-” the purpose and effect of which will be to:

(a) prohibit verge and footway parking in the entire length of Elmwood Drive, Ewell;

(b) provide that such exemptions as in sub-paragraph 1. (4)(b) shall apply.

Where a restriction is proposed herein any existing restriction on the same length of road will be revoked, unless otherwise indicated.

A copy of the made Orders, which will come into operation on 05 March 2024, plans showing the lengths of roads to which the Orders relate, and a Statement of the Council’s reasons for making the Orders may be inspected, free of charge, at

- (6) Ewell Court Library, Ewell Court House, Lakehurst Road, Ewell, KT19 0EB

If you wish to question the validity of any of the Orders or of any provision contained in any of those Orders on the grounds that it is not within the powers conferred by the Act, or on the grounds that any requirement of the Act or of any Instrument made under it has not been complied with in relation to any of the Orders, you may, within six weeks from the date of the making of the Order, apply to the High Court for this purpose.

Any reference to a road in the Schedules is a reference to part of the road only.
