

## THE SURREY COUNTY COUNCIL VARIOUS ROADS IN SHEERWATER TEMPORARY PROHIBITION OF WAITING ORDER 2019

ON 31 JULY 2019 SURREY COUNTY COUNCIL MADE the above mentioned Temporary Order under Sections 14(1) and 15(2) of the Road Traffic Regulation Act 1984, the effect of which will be to prohibit waiting by vehicles in the lengths of roads in the Schedules to this Notice, at the times specified therein. This Temporary Traffic Order is required to enable New Vision Homes to carry out development works, which are anticipated to take in excess of 18 months. The Order, which will commence on 3 August 2019, will remain in operation in any event until such time as all the relevant works have been completed, after which it will be revoked by a further Order. The prohibition will only operate when the relevant traffic signs are displayed. Exemptions are provided to permit vehicles to wait in order to pick up and set down passengers, to load and unload goods, to carry out essential services and works or when used by local authorities in pursuance of statutory powers or duties and for furniture removals, (N.B. Disabled persons displaying a disabled blue badge will not be exempt from the temporary waiting restriction). The usual exemptions apply for Post Office vehicles when delivering or collecting postal packets, vehicles when waiting because they are required by law to stop, are obliged to stop in order to prevent an accident or are prevented from proceeding because of circumstances outside the drivers control and in respect of anything done with the permission or at the direction of a police constable in uniform or of a civil enforcement officer.

**FIRST SCHEDULE:** No waiting at any time:- (1) Spencer Close – the full length of both sides of the entire carriageway covering only those areas of publicly maintained highway, between the junction with Devonshire Avenue and a point 57m north thereof; (2) Devonshire Avenue – both sides from its junction with Spencer Close and a point 20m west thereof.

**SECOND SCHEDULE:** No waiting Monday-Saturday 8am-6pm (1) Devonshire Avenue – north side from the restriction above (20m west of Spencer Close) to a point 15m south of the corner in Devonshire Avenue (to the west); (2) Devonshire Avenue – east side of the corner (at its west end) extending 15m each direction from the centre of the bend; (3) Devonshire Avenue – east side from a point 12m north of the junction with Dartmouth Avenue down to the existing restriction to the south (approximately 20m north of Albert Drive); (4) Devonshire Avenue/Dartmouth Avenue – at the south-eastern corner of Devonshire Avenue at its junction with Dartmouth Avenue between a point 10m along Dartmouth Avenue and the existing restriction on Devonshire Avenue to the south (approximately 20m north of Albert Drive).
