Temporary Prohibition of Traffic Order 2023

On 11 January 2023 Surrey County Council made the above-mentioned Temporary Order under Section 14(1) of the Road Traffic Regulation Act 1984, the effect of which will be to prohibit vehicles from entering or proceeding in that length of: - **a)** D4012 Woodruff Avenue, Burpham that extends from its junction with A3100 London Road for a distance of 60m. **b)** D4012 Weylea Avenue, Burpham that extends from its junction with A3100 London Road for a distance of 28m. **c)** B2234 New Inn Lane, Burpham that extends from its junction with A3100 London Road for a distance of 34m. **d)** D4012 Burpham Lane, Burpham that extends from its junction with A3100 London Road for a distance of 28m. This Traffic Order is required to facilitate Surrey County Council to safely carry out lining and footway/carriageway resurfacing works for the construction of new segregated cycle ways, installation of toucan crossings and parallel crossing, and/or maintenance works in A3100 London Road, Burpham. These works are anticipated to be carried out in sections throughout the 18 month period of operation of this Temporary Order that commences on 16 January 2023.

Advanced warning signs will be displayed and the temporary closures will only operate when the relevant traffic signs are displayed. Access for pedestrians and, dismounted cyclists and equestrians will be maintained at all times. Access for emergency services, residents, businesses, cyclists and equestrians will be maintained via the following vehicular diversion routes: - For Woodruff Avenue - A3100 London Road, B2234 New Inn Lane, D4012 Burnet Avenue and D4012 Woodruff Avenue. For Weylea Avenue - D4012 Weylea Avenue, D4012 Doverfield Road, D4012 Burpham Lane and A3100 London Road. For New Inn Lane Eastbound – A3100 London Road, D4013 Winterhill Way, D4013 Glendale Drive and B2234 New Inn Lane. For New Inn Lane Westbound – B2234 New Inn Lane, D4013 Glendale Drive, D4013 Winterhill Way and A3100 London Road. For Burpham Lane Eastbound – D4012 Burpham Lane, A3100 Clay Lane, A3100 London Road. For Burpham Lane Westbound – A3100 London Road, A3100 Clay Lane and D4012 Burpham Lane. Any vehicle found to be obstructing the highway during these works will be removed to a suitable location outside the limits of the works after all reasonable methods have been undertaken to identify and contact the vehicle's owner.
