Executive Summary

Local authorities under the Childcare Act 2016 have a statutory duty to ensure that there are sufficient high quality childcare places available for families who wish to access them. Childcare is defined as any form of care for a child that is paid for or is funded, including education, any other supervised activity and care registered with Office for Standards in Education (Ofsted) or care offered on a school site.

Sufficient funded early education provision also needs to be made for parents of eligible children even for parents who are not working or training. In England, some two-year-olds and all three- and four-year-olds are entitled to 570 hours of funded early education and childcare per year. The universal entitlement is usually offered as 15 hours per week for 38 weeks (known as a term time place) or up to 52 weeks (known as a stretched place) per year.

Eligible working families can claim an extra 15 hours of childcare per week (30 Hours Funded Childcare), making it 1140 hours of funded childcare per year. This means that Surrey has to have sufficient childcare places for 18,556 two-, three- and four-year-olds.

This childcare sufficiency report is an integral part of our Early Years Strategy and enables us to determine whether there are enough childcare and early education places across all areas of the County. The report is used to manage the childcare market and make sure that:

- There are sufficient childcare and early education places
- That childcare places are of high quality
- That childcare services offered are of a range that meet parents' needs
- That childcare and early education places are accessible to families
- That parents' and carers can make informed decisions on childcare and early years services based on there being enough information.

We manage a mixed market of maintained, voluntary and private providers and strive to ensure that every community can access the full range of provision including FEET, 15 and 30 hours, term time only and all year round.

Data was collected from various sources to effectively analyse the supply and demand for childcare services and to identify gaps in provision.

The report looks at the supply of childcare places in Surrey by finding out the number of childcare places provided by childcare and early education providers, population and demographic information and data from Ofsted inspections of the settings. Demand for childcare services will be evaluated using the take-up rates of early education and childcare services and occupancy rates of the settings.

Surrey in Context

Surrey is one of the Home Counties located in the South East of England. Surrey borders Greater London, Kent, East Sussex, West Sussex, Hampshire and Berkshire and is divided into 11 boroughs and districts: Elmbridge, Epsom and Ewell, Guildford, Mole Valley, Reigate and Banstead, Runnymede, Spelthorne, Surrey Heath, Tandridge, Waverley and Woking.




Surrey's population was 1,203,100, as of the 2021 census, an increase of 6.2% (70,700) since the 2011 census. The largest borough in Surrey is Reigate and Banstead with 150,900 people and the smallest borough is Epsom and Ewell with 80,900 people.

Children aged under 5 in Surrey make up just under 6% of the population. Reigate & Banstead have the highest proportion of under 5s at 13% and Mole Valley the lowest at 6%.

Projected Population in Surrey by Age


For 2023-24, the population of 0-4-year-olds in Surrey was projected to be 60,414 children. This is then projected to steadily decrease over the coming years, with a population of 58,375 children by 2028-29.



Quality of Early Years Provision in Surrey

There are 1,605 early years providers on the Early Years register in Surrey of which 1,221 providers had been inspected as at 31/08/23.

The majority of early years providers on the register in Surrey have an Ofsted inspection outcome of Outstanding or Good, representing 98% (1,196) of providers. A small number of early years providers have an Ofsted inspection outcome of Requires Improvement (15) or Inadequate (5).



Overview of Funded Early Education and Childcare in Surrey

Information sourced from the Early Years Census 2023 and the Schools Census 2023.

In Surrey, when considering whether an area has sufficient childcare places, occupancy of childcare places is categorised as follows:

*Please note that there may be slightly larger variations in demand and density data than seen in previous years due to alterations in our data processing to try and ensure our data reflects the most accurate picture of early years entitlements across Surrey.

Number of funded and unfunded places in Surrey

In Surrey, there are 1,641 providers registered on the EY register with Ofsted (648 childcare on non-domestic, 982 childminders and 11 childcare on domestic) and a further 517 on the childcare register only, offering 33,597 childcare places.

Based on a population figure of 60,414 children under the age of 5 years across Surrey, there is an anticipated demand for 28,610 early years places.

The overall density rate of childcare places across Surrey is 56%. This means for every 100 children aged under five years, there are 56 childcare places available. This has remained consistent from 2022.

The overall density rate of childcare places, based on a projected aggregate demand for childcare places across Surrey is 117%, this means that we have a surplus of childcare places based on our projections of the number of children under 5 requiring a childcare place, accounting for children in reception class and the fact that not all children under the age of 5 will access formal childcare.

The occupancy of childcare places across the county of Surrey is reported to be healthy, as it was in 2022. There has been a slight decrease in occupancy across all childcare places of 1%, however a slight increase in occupancy of funded only places of 1%.

Throughout this document, where 'all childcare places' are referenced, this includes both funded and unfunded places.

Types of Childcare Services Offered in Surrey

Day nurseries remain the most used childcare service in Surrey.

Overall, there has been a decrease in the total number of childcare places (1.8%) and funded only places (2%).

The most significant changes have been seen in the pre-school playgroup sector, with decreases in both the total number of childcare places available (36%) and funded only places available (35%).

Extended Day Play Group provision saw the largest increase in funded only places (6%).

Across Surrey, the day nursery, extended day playgroup and section 27 nursery schools and classes have all seen increases. Maintained and Academy Schools have remained consistent and childminders, pre-school playgroups and independent nursery schools have all seen decreases in places offered.

Number of weeks open - group settings and childminders

In January 2023, there were 15,214 children attending childcare providers open for 38 weeks of the year (term time provision). A further 3,917 children were attending providers opened 39 to 48 weeks of the year, this would typically be a childminding provision. 14,446 children were accessing a full day care setting open for 49 - 52 weeks of the year.

Number of children aged 2 – 5 years eligible for funding

In Surrey in January 2023, there were approximately 1,864 two-year-old children eligible for FEET funding. Surrey has seen a gradual decrease in the number of eligible children in recent years. Compared with January 2022, there were 112 fewer eligible children.

Of these eligible children, 1,364 were accessing their entitlement across 424 providers. As of Spring term 2023, there were 765 providers in Surrey offering FEET funding, 458 group providers and 307 childminders.

In addition to the two year old funding, there are 16,692 three- and four-year-old children eligible for universal 3- & 4-year-old funded early education residing in Surrey. Of these eligible children, 15,777 were accessing their entitlement, with an additional 1,313 children aged 3 or 4 years old, not resident in Surrey.

Of the children accessing their universal 3 & 4 year old entitlement, there were 937 eligible claims for Early Years Pupil Premium (EYPP), these were spread across 4 Local Authority Maintained Nurseries, 59 maintained or academy school nursery classes, 1 childminder and 161 private, voluntary or independent (PVI) providers.

There were also 7,108 children accessing the extended entitlement, across 798 providers. Of these providers, 430 were group providers, 38 were maintained academy schools and 321 childminders.

Children with additional needs (SEND)

Surrey Early Years teams are committed to removing any barriers to children accessing suitable, inclusive Early Years provision within their local community wherever possible. We have a dedicated Early Years SEND team who developed and endorse the Early Years Graduated Response model which promotes all children, including those with additional needs, being educated in their local community. Families of children with SEND have expressed positive feedback in support of this model. All Early Years providers are required to deliver an inclusive offer in accordance with the SEND Code of Practice (0-25) and the Equality Act (2010).

Early Intervention Funding (EIF) provides additional funding to support Early Identification and Intervention to enable Early Years providers to help children reach their full potential in mainstream settings. Across the financial year 2022/23 516 settings were awarded EIF, supporting 2,208 children. This was spread across 90 maintained schools and academies, 418 private, voluntary and independent (PVI) settings, 1 childminder and 8 out of county settings (all children with EHCPs).

Surrey providers have reported that EIF funding has supported children to access settings that they may not have been able to without this support, and that the targets/outcomes set for children by professionals had been met either fully or partially due to access to EIF. There were also positive indications that EIF had allowed successful recruitment and retention of staff to enhance staff ratios:

'EIF has been so beneficial in enhancing our staff ratios and given us confidence to know that if we have a child that needs extra help, we can apply for funding to support them.'

'Absolutely vital to our rising SEN needs in nursery. Couldn't have got through this year without it.'

'As a setting we would struggle without EIF and it would be a strain on staff. The funding enables us to be able to continue to provide a high level of care and education for ALL children.'

Impact of the rising cost of living

Surrey continues to see a changing picture in the way in which families choose to use childcare post-covid and in light of the increased cost of living. This may include but is not exclusive to wraparound and funded hours required, flexible offers, and change in preference for type of provider.

As data used to inform Surrey County Council's Childcare Sufficiency Assessment is collected at the Early Years Census, held in January each year, caution should be taken when considering the data contained in this report. Numbers of settings, two-year-olds and three-year-olds taking up their universal funded entitlement was lower at census than in 2022, however there were increases in take up of the extended entitlement for three-year-olds and both universal and extended for four-year-olds.

- 1.7% fewer early years providers
- 5.1% fewer two-year-olds
- 2.0% fewer three-year-olds universal entitlement

- 9.8% more four-year-olds universal entitlement
- 0.4% more three-year-olds extended entitlement
- 7.7% more four-year-olds extended entitlement

Wrap-around childcare - breakfast, after school and holiday clubs

As of the January 2023 census, there were 396 schools, academies and early years group providers offering wraparound care across Surrey, encompassing breakfast club, after school club and holiday club places.

There are an additional 514 under 5s places offered by schools and academies.

As part of our preparation to ensure that wraparound is available to every primary school aged child who requires it by September 2026, we are undertaking a review of the current availability of wraparound provision to assess the accuracy of the information submitted via census. Early indications suggest that there is more holiday club provision available than reported at census.

Additionally, we are exploring ways to get further insight into the wraparound offer provided by childminders and to gain a further understanding of the extent to which childminders are working in partnership with local schools to offer before and after school care.

Sufficiency of Childcare Places by Borough

Borough of Elmbridge

The Borough of Elmbridge is situated in the North East of Surrey with a mix of urban towns and areas of countryside and villages. The principles towns include Esher, Cobham, Walton On Thames, Weybridge and Molesey, with one civil parish which is in Claygate.

Elmbridge covers an area of 37.2 square miles with a population of 138,800 (based on the 2021 census). Elmbridge borders the Surrey boroughs of Spelthorne, Runnymede, Woking, Guildford and Mole Valley and the London boroughs of Kingston Upon Thames and Richmond.



The graph below illustrates the relationship between the number of FEET eligible children and aggregate demand for Early Years places, with the number of group providers and funded childminders operating in each ward across Elmbridge expressed as a percentage.

Walton South is the ward with the highest aggregate demand and has one of the highest number of FEET eligible children. The ward has the second lowest number of group providers and a moderate number of funded childminders.

Hersham Village has the second highest aggregate demand for Early Years places and is also the ward with the second most group providers and a high number of funded childminders.

Cobham & Downside is one of the wards with higher FEET eligibility, but lower aggregate demand, this ward has the highest number of group provisions across Elmbridge.



The highest number of full day care places (open 8 hours +) are offered in the wards of Weybridge St George's Hill, Hersham Village and Cobham & Downside. There is no full day care provision in Oxshott & Stoke D'Abernon and Oatlands and Burwood Park.

Oxshott & Stoke D'Abernon and Esher have the highest number of extended day playgroup places (open 4 – 7 hours). This provision is not available in Thames Ditton.

Sessional Pre-School Playgroup provision (open less than 4 hours) is available in two wards which are Weybridge Riverside and Walton Central.

Number of funded and unfunded places in Elmbridge

Based on a population figure of 7,475 children under the age of 5 years across Elmbridge, there is an anticipated demand for 3,541 early years places.

The Borough of Elmbridge has the second highest number of under 5s in Surrey. The overall density rate of funded and unfunded childcare places in Elmbridge is 70%. This means for every 100 children aged under five years, there are 70 childcare places available. This has remained stable since 2022.

The overall density rate of childcare places, based on a projected aggregate demand for childcare places across Elmbridge is 149%, this means that we have a surplus of childcare places based on our projections of the number of children under 5 requiring a childcare place.

The occupancy of childcare places across Elmbridge is reported to be not busy for all childcare places and funded only childcare places. Occupancy for total childcare places has remained consistent since 2022, with a 1% decrease in occupancy of funded only places.

Childcare services offered in Elmbridge by type

Overall, there has been a decrease in the total number of childcare places (1%) and funded only places (3%).

The most significant changes have been seen in pre-school playgroups with decreases in all places (30%) and funded only places (28%). There were decreases in places across the board for all childcare providers, other than day nurseries which saw an increase in all places (15%) and funded only places (13%).

Therefore, while there appears to be a reduction of places across most of the sector in Elmbridge, it appears that the day nursery offer is increasing.

The apparent reduction in maintained and academy school places is due to a data processing error in 2022 which meant that one of the providers was previously incorrectly categorised.

Number of weeks open – group providers and childminders

Childcare provision open for 49 - 52 weeks of the year, typically day care provision, is the most popular in Elmbridge, with 2,550 children accessing this in 2023. This is closely followed by provision open for 38 weeks of the year (term-time), with 2,139 children accessing this. A further 579 children were attending a childcare provider open between 39 - 48 weeks of the year. This is more likely to be provision offered by a childminder.

Wrap-around childcare - breakfast, after school and holiday clubs

Elmbridge has the second highest number of providers offering wraparound care (49 providers), the third highest number of breakfast club places (1981 places), the third highest number of after school club places (2348 places) and the most holiday club places (966 places).

Borough of Epsom and Ewell

The Borough of Epsom and Ewell is situated on Surrey's northern border and is the smallest district in Surrey, including the towns Ewell, Epsom, Stoneleigh and Worcester Park. The borough covers an area of 34.07 square miles with a population of 80,900 people (census 2021).

The borough borders Reigate and Banstead and Mole Valley in Surrey and the London boroughs of Sutton and Kingston Upon Thames.


The graph below illustrates the relationship between the number of FEET eligible children and aggregate demand for Early Years places, with the number of group providers and funded childminders operating in each ward across Epsom & Ewell expressed as a percentage.

Town is the ward with the highest number of FEET eligible children and also the highest aggregate demand for Early Years places. Town has the highest number of group providers across Epsom & Ewell and a moderate number of funded childminders.

Court, Stamford and West Ewell are the wards with the highest aggregate demand following Town, but rather than having a high number of group providers, these wards have the highest number of funded childminder places across the borough.

Ruxley has a high number of FEET eligible children and a moderate aggregate demand for places, but there is no group provision in the ward and a small number of funded childminders.

West Ewell has a large number of funded childminders compared with the rest of the wards.



The highest number of full day care places (open 8+ hours) are offered in the wards of Town and Nonsuch. There is no full day care provision in Auriol, Woodcote, Ruxley or West Ewell.

College and Town have the highest number of extended day playgroup places (open 4-7 hours). This provision is not available in Stoneleigh, Auriol, Cuddington, Ruxley and West Ewell.

Sessional Pre-School Playgroup provision (open less than 4 hours) is available in two wards which are West Ewell and Woodcote.

Epsom & Ewell Local Plan

Epsom & Ewell are currently in the process of working on a new Local Plan outlining how the communities and borough will develop over the coming years. Looking at the Local Plan for Epsom & Ewell can help us to understand where areas of development may be taking place and how this may impact on the sufficiency of early years provision in the area.

Number of funded and unfunded places in Epsom and Ewell

Based on a population figure of 4,183 children under the age of 5 years across Epsom & Ewell, there is an anticipated demand for 1,980 early years places.

The Borough of Epsom and Ewell has the ninth highest number of under 5s in Surrey. The overall density rate of funded and unfunded childcare places in Epsom and Ewell is 57%. This means for every 100 children aged under five years, there are 55 childcare places available. This is an increase of 2% since 2022.

The overall density rate of childcare places, based on a projected aggregate demand for childcare places across Epsom & Ewell is 121%, this means that we have a surplus of childcare places based on our projections of the number of children under 5 requiring a childcare place.

The occupancy of childcare places across Epsom and Ewell is reported to be not busy for all childcare places and funded only childcare places. There has been a decrease in occupancy for all childcare places of 2%, but an increase in occupancy of 2% for funded only places.

Childcare services offered in Epsom and Ewell by type

Overall, there has been a decrease in the total number of childcare places (6%) and funded only places (7%).

The most significant changes have been seen in pre-school playgroups with decreases in all places (55%) and funded only places (55%). Independent school nurseries also saw a decrease in overall places (26%) but an even larger decrease in funded only places (32%).

Generally, the trends in Epsom and Ewell are reflective of changes seen across Surrey as a whole, however, the key difference being a decrease in day nursery places where in general there has been an increase.

Number of weeks open – group settings and childminders

Childcare provision open for 38 weeks of the year (term-time) is most popular in Epsom & Ewell, with 1,072 children accessing this in 2023. This is closely followed by provision open for 49-52 weeks of the year, typically day care provision, with 1,041 children accessing this. A further 273 children were attending a childcare provider open between 39 – 48 weeks of the year. This is more likely to be provision offered by a childminder.

Wrap-around childcare - breakfast, after school and holiday clubs

Epsom & Ewell has the least providers offering wraparound care (23 providers), the ninth highest number of breakfast club places (1090 places), the ninth highest number of after school club places (1144 places) and the third highest number of holiday club places (499 places).

Borough of Guildford

Guildford is the largest settlement and the only town within the borough and the busiest of Surrey's boroughs with 22 wards. It borders with the County of Hampshire and with Woking, Waverley, Surrey Heath, Mole Valley and Elmbridge in Surrey.

Guildford covers an area of 104.6 square miles and has a population of 143,600 people (census 2021).



The graph below illustrates the relationship between the number of FEET eligible children and aggregate demand for Early Years places, with the number of group providers and funded childminders operating in each ward across Epsom & Ewell expressed as a percentage.

Christchurch is one of the wards with lower FEET eligibility and overall aggregate demand, however, is one of the wards with the largest number of group providers.

Stoughton has a high number of funded childminders compared with the rest of the wards across Guildford and has one of the higher levels of aggregate demand across the borough.



The highest number of full day care places (open 8+ hours) are offered in the wards of Christchurch and Friary & St Nicolas. Full day care provision is not available in Normandy, Effingham, Pilgrims, Send, Shalford, Ash Wharf, Stoke and Merrow.

Westborough and Ash Wharf offer the highest number of extended day playgroup places (open 4 – 7 hours) across Guildford. This type of provision is not available in Send, Shalford, Ash Vale and Stoughton.

Sessional Pre-School Playgroup provision (open less than 4 hours) is available in two wards which are Burpham and Merrow.

Number of funded and unfunded places in Guildford

Based on a population figure of 6,277 children under the age of 5 years across Guildford, there is an anticipated demand for 2,973 early years places.

The Borough of Guildford has the third highest number of under 5s in Surrey. The overall density rate of funded and unfunded childcare places in Guildford is 57%. This means for every 100 children aged under five years, there are 55 childcare places available. This is an increase of 2% since 2022.

The overall density rate of childcare places, based on a projected aggregate demand for childcare places across Guildford is 121%, this means that we have a surplus of childcare places based on our projections of the number of children under 5 requiring a childcare place.

The occupancy of childcare places across the borough of Guildford is reported to be healthy for all childcare places and funded only childcare places. The occupancy of all places has remained consistent since 2022, however there has been a 2% decrease in funded only occupancy.

Childcare services offered in Guildford by type

Overall, there has been an increase in the total number of childcare places (2%) and funded only places (0.7%).

The most significant changes have been seen in pre-school playgroups with decreases in all places (35%) and funded only places (36%). Independent school nurseries also saw a decrease in overall places (26%) but an even larger decrease in funded only places (32%).

The most significant increase has been seen in nursery school and nursery classes, with an increase of over 100% for total places and funded only places. Other significant increases were also seen for extended day playgroups for all places (24%) and funded only places (28%).

The apparent reduction in maintained and academy school places is due to a data processing error in 2022 which resulted in two providers being mistakenly included in these numbers, one of which being a specialist provision.

Childcare provision open for 49 - 52 weeks of the year, typically day care provision, is the most popular in Guildford, with 1,532 children accessing this in 2023. This is closely

followed by provision open for 38 weeks of the year (term-time), with 1,524 children accessing this. A further 540 children were attending a childcare provider open between 39 – 48 weeks of the year. This is more likely to be provision offered by a childminder.

Wrap-around childcare - breakfast, after school and holiday clubs



This is followed by provision open for 49-52 weeks of the year, typically day care provision, with 650 children accessing this. A further 267 children were attending a childcare provider open between 39 - 48 weeks of the year. This is more likely to be provision offered by a childminder.









The overall density rate of childcare places, based on a projected aggregate demand for childcare places across Surrey Heath is 110%, this means that we have a surplus of childcare places based on our projections of the number of children under 5 requiring a childcare place.

The occupancy of childcare places across Surrey Heath is reported to be healthy for all childcare places and funded only childcare places. This shows a decrease in occupancy of all childcare places of 3% but an increase of 8% for funded only places since 2022.

However, although there has been an increase in all places at independent school provision, the number of funded places has reduced.

Number of weeks open – group settings and childminders

Childcare provision open for 38 weeks of the year (term-time) is most popular in Surrey Heath, with 995 children accessing this in 2023. This is followed by provision open for 49-52 weeks of the year, typically day care provision, with 852 children accessing this. A further 287 children were attending a childcare provider open between 39 – 48 weeks of the year. This is more likely to be provision offered by a childminder.

Wrap-around childcare - breakfast, after school and holiday clubs

The borough of Surrey Heath has the sixth largest number of providers offering wraparound care (32 providers), the second number of breakfast club places (2426 places), the second highest number of after school club places (2604 places) and the sixth highest number of holiday club places (387 places).

District of Tandridge

The district of Tandridge is located in the East of Surrey, bordering the London Boroughs of Croydon to the north and Bromley to the North East, Sevenoaks in Kent, Crawley in West Sussex and Wealden in East Sussex and Reigate and Banstead in Surrey.

The district covers an area of 95.8 square miles with a population of 87,900 people (2021 census).



The graph below illustrates the relationship between the number of FEET eligible children and aggregate demand for Early Years places, with the number of group providers and funded childminders operating in each ward across Tandridge expressed as a percentage.

Oxted South has both the highest aggregate demand and one of the highest levels of FEET eligibility but is not one of the wards with higher numbers of group providers or funded childminders.

The six wards with the lowest aggregate demand, Chaldon, Felbridge, Tatsfield & Titsey, Woldingham, Dormansland & Felcourt and Warlingham West have no funded childminder provision. This provision is available in all other wards.

The wards with lower aggregate demand, also generally have lower FEET eligibility, with the exception of Felbridge.



The highest number of full day care places (open 8+ hours) are offered in the wards of Oxted North & Tandridge, Queens Park and Bletchingley & Nutfield. Full day care provision is not available in Chaldon, Felbridge, Woldingham, Warlingham West, Warlingham East & Chelsham & Farleigh, Valley, Whyteleafe and Oxted South.

Extended day playgroup provision (open 4-7 hours) is not available in the wards of Godstone, Harestone, Limpsfield, Portley, Queens Park and Whyteleafe. Warlingham East & Chelsham, Oxted North & Tandridge and Westway have the most of this provision available.

Oxted South is the only ward where Sessional Pre-School Playgroup provision (open less than 4 hours) is available in the district of Tandridge.

Number of funded and unfunded places in Tandridge

Based on a population figure of 4,629 children under the age of 5 years across Tandridge, there is an anticipated demand for 2,187 early years places.

The district of Tandridge has the seventh highest number of under 5s in Surrey. The overall density rate of funded and unfunded childcare places in Tandridge is 60%. This means for every 100 children aged under five years, there are 60 childcare places available. This is an increase of 2% since 2022.

The overall density rate of childcare places, based on a projected aggregate demand for childcare places across Tandridge is 127%, this means that we have a surplus of childcare places based on our projections of the number of children under 5 requiring a childcare place.

The occupancy of childcare places across Tandridge is reported to be not busy for all childcare places funded only childcare places. This shows a decrease in occupancy of all childcare places and funded only places of 6% since 2022.

Overall, there has been an increase in the total number of childcare places (2%) and funded only places (4%).

The most significant changes have been seen in pre-school playgroup provision, with a decrease in all places (36%) and funded only places (30%). Conversely, there has been an increase in the total places (21%) and funded only places (22%) available at extended day playgroup provision.

Where there has been increases in the total number of places available at extended day playgroups and day nurseries, both have seen larger increases in the number of funded only places, compared with overall places.

Childcare provision open for 49 – 52 weeks of the year, typically day care provision, is the most popular in Tandridge, with 1,321 children accessing this in 2023. This is closely followed by provision open for 38 weeks of the year (term-time), with 1,158 children

accessing this. A further 295 children were attending a childcare provider open between 39 – 48 weeks of the year. This is more likely to be provision offered by a childminder.

Wrap-around childcare - breakfast, after school and holiday clubs

Tandridge has the joint seventh largest number of providers offering wraparound care (30 providers), the tenth highest number of breakfast club places (842 places), the eighth highest number of after school club places (1355 places) and the seventh highest number of holiday club places (376 places).

Borough of Waverley

The borough of Waverley is located in the South West of Surrey, bordering Hampshire to the West, Chichester and Horsham in West Sussex and Guildford and Mole Valley in Surrey.



The graph below illustrates the relationship between the number of FEET eligible children and aggregate demand for Early Years places, with the number of group providers and funded childminders operating in each ward across Waverley expressed as a percentage.

Godalming Charterhouse is the only ward with no provision available, the ward has moderate aggregate demand and FEET eligibility.

Farnham Castle is the ward with the highest FEET eligibility, but one of the lower aggregate demand rates.

Farham Weybourne & Badshot Lea has both the highest number of group providers and funded childminders, whilst having a moderate aggregate demand and FEET eligibility.



The highest number of full day care places (open 8+ hours) are offered in the wards of Godalming Farncombe & Catteshall, Farnham Moor Park and Farnham, Weybourne & Badshot Lea. There is no full day care provision in Blackheath & Wonersh, Frensham, Dockenfield & Tilford, Farnham Castle, Cranleigh West, Farnham Wrecclesham & Rowledge, Godalming Charterhouse, Bramley, Busbridge & Hascombe and Godalming Binscombe.

The occupancy of childcare places across Waverley is reported to be healthy for all childcare places and not busy for funded only places. This shows an increase in occupancy of all childcare places of 3% and an increase of 5% for funded only places since 2022.

There have been decreases in the number of places across most types of provision across Waverley, the exception being an increase in extended day playgroup provision and funded only places with a childminder.

This is closely followed by provision open for 49-52 weeks of the year, typically day care provision, with 1,847 children accessing this. A further 321 children were attending a childcare provider open between 39 – 48 weeks of the year. This is more likely to be provision offered by a childminder.

Wrap-around childcare - breakfast, after school and holiday clubs

The borough of Waverley has the largest number of providers offering wraparound care (54 providers), the fourth highest number of breakfast club places (1626 places), the fourth highest number of after school club places (1949 places) and the eighth highest number of holiday club places (346 places).

It should be noted that all wards in the borough of Woking have higher numbers of children eligible for FEET and that demand across all wards in Woking is high.


The ward in Woking with the most children eligible for FEET and the greatest aggregate demand for early years places is Canalside, however Canalside also has the fewest group providers and funded childminders.

Canalside has almost double the number of FEET eligible children, compared with the ward with the next highest eligibility.

Horsell has the lowest demand and lowest number of FEET eligible children but is one of the wards with the most group providers and funded childminders.

Hoe Valley has one of the highest aggregate demands and numbers of FEET eligible children, and also is one of the wards with higher numbers of group providers and funded childminders.

The overall density rate of childcare places, based on a projected aggregate demand for childcare places across Woking is 106%, this means that we have a surplus of childcare places based on our projections of the number of children under 5 requiring a childcare place.

The occupancy of childcare places across Woking is reported to be healthy for all childcare places and funded only childcare places. The occupancy of all childcare places has decreased by 4% and funded only places has remained consistent since 2022.

Day nurseries remain the most used childcare provision in Woking.

Overall, there has been an increase in the total number of childcare places (2%) and funded only places (2%).

The most significant changes have been seen in pre-school playgroups, with a decrease in all places (43%) and funded only places (40%).

Where there has been an increase in day nursery places, there has been a greater increase in funded only places, compared with the total number of places available. Additionally, although there has been an increase in the overall number of places at independent school nurseries, the funded only provision has decreased at this type of provider.

Childcare provision open for 38 weeks of the year (term-time) is most popular in Woking, with 1,587 children accessing this in 2023. This is followed by provision open for 49-52 weeks of the year, typically day care provision, with 1,112 children accessing this. A further 228 children were attending a childcare provider open between 39 – 48 weeks of the year. This is more likely to be provision offered by a childminder.

Wrap-around childcare - breakfast, after school and holiday clubs

The borough of Woking has the fifth largest number of providers offering wraparound care (32 providers), the fifth highest number of breakfast club places (1248 places), the fifth highest number of after school club places (1549 places) and the second highest number of holiday club places (544 places).

Action plan:

Areas of possible insufficiency of places, based on our projected aggregate demand for places, have been identified in Runnymede and Spelthorne. Looking at the data in some more detail, for some of the wards that show an insufficiency it would be possible for children to access a childcare place in a neighbouring ward either within the borough or in a neighbouring one where there is reported to be a surplus of places, but this wouldn't be sufficient for the whole of the projected deficit.

Further consideration has been taken to the reported occupancy of each of the boroughs. Information provided at census showed that providers in Runnymede were operating at a healthy occupancy for all childcare places and a busy occupancy for funded only places and for Spelthorne, providers were at a healthy occupancy for both. This information doesn't necessarily suggest that there is an insufficiency as providers are not reporting to be operating at capacity with no remaining places available.

As part of the ongoing work around the implementation of the expansion of funded entitlements, we are undertaking detailed consultation with parents/carers and providers and will use this as an opportunity to better understand the childcare needs of families in these areas. We also plan to look at distance travelled data for families within these boroughs to understand if they are typically having to travel further to access provision that those across the county. Using this information, we will be in a better position to consider what action can be taken to support the childcare offer in these boroughs.
