B2037 Antlands Lane and B2037 Effingham Road, Smallfield
Temporary Speed Limit and Banned Turn Order 2023

On 15 March 2023 Surrey County Council made the above-mentioned Temporary Order under Section 14(1) and (7) of the Road Traffic Regulation Act 1984 the "Act", the effect of which will be to: - **1.a)** Prohibit vehicles that are proceeding in an easterly direction on B2037 Antlands Lane, Shipley Bridge from turning right into C67 Keepers Corner. Alternative route: - Effingham Road - eastbound, to its roundabout junction with West Park Road and Snow Hill, to return on Effingham Road - westbound to take the left turn into Keepers Corner. **b)** Prohibit vehicles that are proceeding in a westerly direction on B2037 Effingham Road, Burstow from turning right into C67 Redehall Road. Alternative route: Antlands Lane - westbound, to its roundabout junction with Balcombe Road, to return on Antlands Lane – eastbound to take the left turn into Redehall Road. **2.** "The Surrey County Council ((Various Roads in Tandridge and Mid Sussex)(Restricted Roads 20MPH 40MPH and 50MPH Speed Limits) Order 2003)" as amended and "The Surrey County Council (Various Roads in Bletchingley Burstow Godstone Horne Felbridge Limpsfield Nutfield and Oxted) (40 mph Speed Limit and 50 mph Speed Limit) Order 1999", and any Order made under Sections 81, 82, 83 and 84 of the "Act" shall be suspended insofar as affects the lengths of road specified and described in the First Schedule to this Notice whereby a speed limit of 30MPH will apply to the length of road specified and described in part (ii) to the First Schedule to this Notice by virtue of the system of streetlighting. **3.** Impose a speed limit of 30MPH on the length of road specified and described in part (i) to the First Schedule to this Notice.

This Traffic Order is required to enable Surrey County Council to carry out junction improvement works, to include but not limited to installation of a traffic island and/or resurfacing and/or maintenance works. These works are anticipated to be carried out between the hours of 8am and 4:30pm within 9 days of the 18 month period of operation of this Temporary Order that commences on 20 March 2023. Advanced warning signs will be displayed and the temporary banned turns and speed limit which are anticipated to be required for 24 hours each day, will only operate when the relevant traffic signs are displayed. Access for pedestrians and, dismounted cyclists and equestrians will be maintained at all times. No sole access to any property will be affected. Access for emergency services, residents and businesses will be maintained at all times via the vehicular diversion routes described above. The speed limit imposed by this Order shall not apply to vehicles used by special forces in accordance with the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 or in respect of anything done with the permission or at the direction of a police constable in uniform or in accordance with any restriction or requirement indicated by traffic signs placed on the highway by or on behalf of the Police.

SCHEDULE 1. (i) B2037 Antlands Lane, Shipley Bridge that extends from its junction with B2037 Effingham Road, C67 Keepers Corner and C67 Redehall Road, for a distance of 100m. (ii) B2037 Effingham Road, Burstow that extends from its junction with B2037 Antlands Lane, C67 Keepers Corner and C67 Redehall Road, for a distance of 100m.
