Gatton Park Road (A242) Redhill
Temporary Prohibition of Traffic Order 2023

On 25 January 2023 Surrey County Council made the above mentioned Temporary Traffic Order under Section 14(1) of the Road Traffic Regulation Act 1984 the effect of which will be to prohibit vehicles from entering or proceeding in that length of Gatton Park Road (A242) Redhill which extends from its junction with (A23) London Road to a point approximately 200 metres southwest of its junction with (D1253) Colesmead Road. This Order, which will commence on 13 February 2023 for a period of 12 months is required to facilitate the construction of road tables and speed cushion works to be completed by or on behalf of Surrey County Council. These works are anticipated to be completed over a period of approximately 10 days between the hours of 9.30am and 4.30pm. Advanced warning signs will be displayed and the temporary closure will only operate when the relevant traffic signs are displayed. Access to premises within the affected length of road, including access by emergency service vehicles to these properties, will be maintained at all times, as will access for pedestrians and cyclists. All other traffic will be required to follow the alternative route described below. **Alternative Route- Except HGV's/ Vehicles above 14'9"**. (A242) Gatton Park Road, (A242) Croydon Road, (A25) Reigate Road, (A25) Hatchlands Road, (A25) Linkfield Corner, (A25) Station Road, (A25) Queensway, (A25) London Road, (A23) London Road and (A242) Gatton Park Road or this route in reverse.

Alternative Route for HGV's/ Vehicles above 14'9"- From North-Eastern Direction- (A242) Gatton Park Road, (A242) Croydon Road, (D1210) Raglans Road, (A217) Reigate Hill, (A217) London Road, (A25) London Road, (A25) High Street, (A25) Church Street, (A25) Reigate Road, (A25) Hatchlands Road, (A25) Linkfield Corner, (A25) Station Road, (A25) Queensway, (A25) London Road, (A23) London Road and (A242) Gatton Park Road.

From South-Western Direction- (A23) London Road, (A25) Queensway, (A25) Station Road, (A25) Linkfield Corner, (A25) Hatchlands Road, (A25) Reigate Road,

(A25) Castlefield Road, (A217) London Road, (A217) Reigate Hill, (D1210) Raglands Road and (A242) Gatton Park Road.
