As a care leaver you would not generally be entitled to Universal Credit while undertaking a course of higher education (HE) so this is a quick reference document about the support you can access.

## **Financial**

When applying to university, many students are worried about managing their money – and for students from a care background, this may seem like a particular challenge.

You should apply for student finance to cover your tuition fees and maintenance as an **independent student** – this means your household income is not to be taken into account in calculating what you can receive. There are guides to help you apply for student finance in <u>England</u>, <u>Wales</u>, <u>Scotland</u> and <u>Northern Ireland</u>.

When it comes to repaying any student loan, don't worry – you won't be expected to start making payments until you graduate and are earning above a certain amount. Read all about student finance and how to apply around the UK


In addition, you may be eligible for further financial help as a care-experienced student, such as:

- **England and Wales**: A Higher Education Bursary, which you don't pay back contact your local authority or personal advisor for details.
- Bursaries from a university or college: Many universities and colleges offer bursaries for care-experienced students that you don't have to repay, and some offer grants or loans to help you manage any additional expenses (e.g. specialist equipment). Speak to the university or college directly, or check the Propel website.
- Charitable organisations: There are a number of organisations offering grants, bursaries and scholarships, including <u>Unite Foundation</u>, <u>Buttle UK</u>, and the <u>Care Leavers' Foundation</u>.

# Accommodation

Many universities and colleges help care-experienced students to find appropriate accommodation. This varies greatly from one institution to another, so make sure you check early on in your research, as it could be an important factor when you're choosing where to study.

#### Help may include:

- free or discounted accommodation;
- year-round accommodation (including over the holiday periods);
- a guaranteed room in university accommodation for the duration of your course;
- no guarantor requirement or the university will act as guarantor on your behalf;
- no deposit needed, or reduced cost;
- grants to help you cover living costs over the holiday periods;
- starter packs to help you get the equipment you need (e.g. bedding) or vouchers.

UCAS fees can be requested from the Care Leavers' Service if necessary. The application form can be found using the link below. All young people need to register in the UCAS Hub to start and access their application, There is only one single sign-in for students to both access their application and track their offers and decisions.

Following your acceptance to higher education, the Care Leavers' Service will gather the required evidence and carry out an assessment of need and may provide the following financial support:

**HE accommodation costs during the holidays**: As outlined above you will be eligible for student finance loans and are expected to fund course tuition fees and the cost of halls/student accommodation for the duration of your course (if other grant/benefits are not awarded by your chosen institution).

However, The Care Leavers' Service can fund accommodation costs during the holidays, e.g. 'staying put' arrangements on a pro-rata basis whilst you are in HE. (This will be subject to evidence of your attendance and attainment provided by your tutor on a termly basis). The funding will be in line with the local housing allowance rate for the area.

**Living Allowance:** - Half of the current Universal Credit Allowance rate, will be paid over the duration of the course, during term-time.





### **Support from Surrey Care Leavers' Service (continued)**

**Bursary -** In line with regulations, a one-off higher education bursary of £2,000 will be awarded for the duration of the course, paid in instalments of £250 on a termly basis, to all care leavers undertaking a higher education course, (subject to evidence of a minimum of 85% attendance). This does not include one-year Access Foundation courses which may be undertaken before a degree course.

**Internet costs** of up to £20 per month.

**Books and equipment** - Up to £100 for essential books. Requests for specialist equipment will be assessed. Contributions will be considered on an individual basis.

Support to care leavers undertaking work placements during their courses. Students will be expected to secure all relevant bursaries/loans for which they are eligible. Care Leavers should check with their institution to understand what financial support is available whilst they are on the work placement.

In the event that students have to move to an area where housing costs are higher in order to secure a work experience placement, the Local Authority would pay the difference between the Local Housing rate in the university area and that in the area where students are living in order to undertake the work placement.

Please note that course fees are not covered by Surrey and the finance policy does not cover the full or partial costs to young people of continuing in education on post-graduate courses such as Master's Degrees or Doctorate studies.

# Returning to Education


Care Leavers wishing to return to the service to re-enter education aged 21 plus must:

- Have started their course of education before their 25th birthday.
- Provide evidence from the Home Office for former UASC of their entitlement to remain in the UK, confirming that this extends to the end date of the course.
- · Meet the entry requirements for the course.
- Have confirmation of an accepted offer of a place on the course.
- Be pursuing a recognised full-time education course of 16+ hours a week.

For Care Leavers turning 25 during their undergraduate course, support will be provided to the end of the academic year in which they turn 25, with an assessment of need to identify further sources of funding.

If you previously ended your involvement with us and are now a returning Care Leaver who is requesting funding from the Local Authority in relation to re-entering education, this would be determined through an assessment of need under the Children and Social Work Act 2017.


