Discussed the Public meeting on the 5 January 2023

Community expressed concern following information that the section of London Road from New Inn Lane to the Boxgrove roundabout would be closed in one direction for 5 months. Confirmed that the 5 month closure will no longer happen.

Redesign of scheme underway

Following the public meeting Surrey County Council have continued to work on how they can engage with the community more efficiently.

Stakeholder Group established following stakeholder mapping and analysis.

What do we as a group want to achieve from these meetings?

Starting from a challenging position.

Move away from statistical data – opinions not numbers are the important factor.

Differing views – Very against the scheme, very pro the scheme, or main concern is the delivery and how this will affect day to day live of residents and road users.

Concerns over the initial design – width of road and floating bus stops being the main point.

Focus needed on the safety of the scheme – both delivery and design.

Concerns over the delivery

How can we engage with younger people as they tend not to engage with traditional methods

Important need to engage with George Abbot school due to immediate location and number of pupils/staff attending.

Negative language around the scheme needs to be removed from communications (Poster at Kings Parade)

How to capture a wider group and out of area people.

The issue was raised that the updated design of the scheme in its entirety (London Road full length and Dutch style Roundabout) needs to be seen to enable a better understanding and to enable better engagement with the community.

Potential need to revise the engagement plan schedule to align with updated design availability.
