




North West Surrey Local Valuing People Group Discussion Notes




Helen Hunt and Carinder Malhi chaired the meeting.

Questions Answers and Comments on LeDeR Report for Lynne:







Helen asked about the average age of death for people Learning Disabilities comparing it general population (without learning disabilities), how does the Surrey number compare to the national figure (the figure in the rest of England)?

Lynne replied to the Surrey numbers compares better to national figure.



Women with Learning Disabilities live 19.5 years shorter than women without learning disabilities this is still not good enough still, work needs to be done to improve this.

Helen – terms of learning and actions going forward. In report, is there a similar report for Frimley footprint?

works together.






Carinder commented saying he has issues getting a hospital passport.

Amanda also put a link for a hospital passport in the chat. From our Learning Disability and Autism Hub health webpage- hospital passport.










There was a question in the chat about covid-19. As the pandemic is over, what information is available for people that have Learning Disabilities about covid, as they can have stronger symptoms.






Carinder said he enjoyed the webinars during Learning disability week, he also enjoyed the Adult Learning activities.

Angie mentioned the work and discussions she has had about social workers and wanted to show this is an ongoing issue, bringing up in reviews and interactions with social care, service users, repeat stories several times is important not to do. Common theme, that is constantly raising.









Reading the file before another social worker arrives is important, would make it easier. Not assuming existing information is old, historical information may still be relevant.

Helen replied saying that, this feedback is not uncommon a lot of people repeat that; review process should be smoother.

physical activity, so these types of stories are positive and inspiring.

Providers are encouraged to help their service users get their Pegasus card

especially when they are being independent and going out.

Questions, Answers and Comments about the Future of the Valuing People Group for Amanda and Helen.





Amanda talked about the Valuing People Group, and the initial purpose of the meeting.

Amanda suggested that the Valuing People Group is more locally focussed, work together to solve, and change things in the local area.

It has become online and not in person, people with LD have stopped engaging as have carers, how to re start this in the North West.





Event or meet in person, solve issues in their local area.

An example, co-chair — difficulties with access swimming pool and Donyngs, lots of barriers. Covid introduced complicated booking systems. We were able to reach to people who manage the contracts to leisure centres. This was addressed, and the cochair was able to speak to them and the feedback was taken on.

That kind of thing to be happen in the next year.

Amanda asked Carinder, why are people with Learning Disabilities not coming.

Carinder said people have other things to do, needs to be more engaging, Eventbrite could be helpful.





Amanda said meeting in person can be useful as it is more engaging, people love to see each other. The group agreed.




Carla – has sent an email to Carinder to link up with the work she is doing.

or leisure centres, adult learning centres etc.


Carinder suggested having one meeting where everyone comes together (all the groups) then they split off to breakout rooms.

Amanda, getting feedback from people, about issues locally, barriers etc and working with that.


Helen asked if Amanda is you bringing this to the other groups.
