### Government launches consultation on the future of local government in Surrey

Earlier this week, the government <u>launched a consultation</u> on Local Government Reorganisation (LGR) in Surrey. This consultation is part of the government's devolution plans for transferring more powers from government to local or regional authorities. Please share with your colleagues, partners, residents and networks. The consultation closes at 5pm on Tuesday 5 August.

Surrey County Council, Elmbridge Borough Council and Mole Valley District Council are recommending that Surrey is arranged into two new unitary councils, East Surrey and West Surrey. These two councils would work with an elected Mayor who would create a new Strategic Authority covering the county of Surrey. This plan is supported by key local partner organisations, including health, police and fire, business and community leaders.

Other proposals have also been put forward to government including a three-unitary council plan.

Surrey County Council, Elmbridge Borough Council and Mole Valley District Council are hosting an online resident information event on 7 July, 7pm – 8:15pm, to explain LGR and the two unitary council proposal. The event will include a question and answer section, with questions received in advance via the <u>registration form</u>, by email at <u>devolutionandlgr@surreycc.gov.uk</u> or live during the event. The event will be held on MS Teams. It will be recorded and shared with British Sign Language interpretation for anyone unable to attend the event to watch when convenient for them.

# Share your views on proposed changes to adult social care charges

Surrey County Council is asking for views on proposed changes to how much adults pay for care at home or in the community, aimed at bringing their approach in line with national guidance.

National social care laws allow councils to ask people to contribute towards the cost of their care and set out how much can be charged. In Surrey, people have been charged less than the national guidance recommends for home and community-based care. However, when less money is collected through charging, there's less funding available to run and improve the care services that many people rely on.

Surrey County Council is not proposing changes to the policy for people living in residential or nursing care, where charging is already in line with national guidance.

### The proposals

The **first proposal** would affect people who have capital above £23,250. Capital means the money or assets that people own (such as savings in the bank or building society) and does not include the value of the property they live in.

Surrey County Council is proposing a change so that if someone has more than £23,250 in capital, they would need to pay the full cost of their care. At the moment, the threshold amount is £24,500.

The **second proposal** is about how Surrey County Council works out what people pay for their care if they have capital between £14,250 and £23,250. If someone has capital between the lower threshold of £14,250 and the proposed amended upper threshold of £23,250, they are proposing to add a little bit of extra money each week - £1 for every £250 of capital - to what they pay. This is known as charging 'tariff income' - where an amount of savings is treated like weekly income. The maximum amount of tariff income would be £36.00 per week.

#### How to share your views

Surrey County Council would like to hear people's views on the proposed changes to the policy. The consultation period will last for 12 weeks from Monday 16 June 2025 and will close at **23:59pm on Sunday 7 September 2025**. Views can be shared as follows:

# Change to Aldershot Safe Haven Opening Hours - From 1 June 2025

From Sunday 1 June 2025, there has been a permanent change to weekend and Bank Holiday opening hours at Aldershot Safe Haven.

The service will no longer be open from 12.30pm to 6pm on weekends and Bank Holidays. This change brings Aldershot Safe Haven's opening hours in line with the four other Safe Haven services in Epsom, Guildford, Redhill, and Woking. Evening hours remain unchanged, with in-person support available every day from 6pm to 11pm, including weekends and Bank Holidays - 365 days a year.

Aldershot Safe Haven is provided in partnership with Catalyst, Andover Mind, and Surrey and Borders Partnership NHS Foundation Trust. Safe Havens offer out-of-hours help and support to adults experiencing a mental health crisis or emotional distress, as well as their carers. They provide a safe, welcoming alternative to A&E for those in urgent need of mental health support.

For those who need support outside of Safe Haven opening hours, the 24-hour Mental Health Crisis Line (0800 915 4644) remains available to everyone in Surrey and Northeast Hampshire.

### Community safety and cohesion survey launched

Surrey County Council has commissioned an independent research agency, Solutions Research Ltd to conduct research among Surrey residents aged 16 and over. This research is to understand areas of concern around community safety and cohesion, and to inform interventions that meet community needs.

The <u>survey</u> will gather information on experiences with crime, anti-social behaviour, discrimination or feelings of belonging. Feedback will help shape Surrey's future partnership strategy around community safety and cohesion, ensuring it reflects the real experiences of local people.

### Royal Surrey invites the public to explore healthcare services

Royal Surrey County Hospital in Guildford, will open its doors for a free <u>Community Open Day</u> on Saturday 28 June from 11am to 3pm, offering everyone a chance to discover the world-class healthcare on their doorstep.

Visitors will have the opportunity to tour an operating theatre and see one of the Trust's advanced surgical robots in action. They can also observe how treatments are delivered using simulation patients. Careers sessions will be available, offering the chance to speak with healthcare professionals about how to begin a career in the NHS.

Throughout the event, Royal Surrey's hospital and community teams will demonstrate the wide range of care they provide from newborns to older adults. Blood pressure checks, CPR lifesaving training and advice on improving sleep quality will be offered along with tours of the new Cancer Centre, and the Prostate Project will be on site offering free PSA blood tests to help detect prostate cancer. Emergency services will also be present, giving visitors the chance to see a fire engine, first responder unit, and police car up close.

# Shining a light on the challenges for people with dementia

CQC has published a <u>Health and social care support for people with dementia report</u> that looks at the experiences of people with dementia who use health and care services, and how services are responding. The report found that people did not always feel there was ongoing care and had to seek out community charity support groups themselves. They also saw examples of how good care has a positive impact on people's wellbeing.

They will use the findings in this report to help shape our work to define what good care looks like for people with dementia and inform the next phase of CQC's Dementia Strategy.

### **Catalyst Community Connection Referrals**

Catalyst Support can offer support with mild to moderate mental health difficulties, psychological challenges linked to life transitions or situational stressors and those willing and able to engage in short term one to one interventions and group activities.

They are unable to support with active alcohol or drug dependence that requires specialist addiction services, severe, complex or treatment resistant psychological conditions requiring intensive support or complex or high-risk cases involving significant self-harm or active suicidal ideation that may require crisis intervention.
